Subject: Authorize Transfer of \$1,250 from the General Fund Contingency to the Crescent Mills Lighting District to cover Unforeseen Expenses

Background:

The Fiscal Year 2011/12 budget adopted for the Crescent Mills Lighting District (CMLD) is projected to have insufficient funds to cover expenditures for this current fiscal year.

Since the adoption of the FY11-12 Budget, unforeseen costs have impacted the budget.

The unforeseen costs that occurred since adoption of the FY11-12 budget are as follows:

- Plumas County, through the Auditor's Office, charged "overhead" to the District, whereas no overhead cost, prior to this FY 2011-12, had been charged in previous years. Amount = \$ 207.00
 - On 9/20/2011, the CAO assessed a "Reduced Utilities" charge upon the District. Amount = \$ 974.00
 - Reduction in property tax receipts during FY11-12. Amount = \$ 41.00
- Total Amount = \$ 1,222.00

The above unforeseen costs will result in insufficient revenues in order to pay all expenses for the Fiscal Year 2011/12.

The CMLD possesses no reserves on which to offset the shortage of funds.

CMLD has already received and expended its revenue from Public Works Road Fund, utilizing the departments "25% Rule." In fact, in order to avoid recent disconnect action by PG&E, Public Works has advanced funds to the CMLD in excess of the 25%. Such excess funds need to be paid to the Road fund before the end of FY 2011/12.

Attached, for your reference, is a copy of an Expenditure Report, dated June 4, 2012, and a Fund Balance Sheet, dated June 4, 2012.

Recommendation:

Staff respectfully recommends that the Board of Supervisors authorize a general fund contingency expenditure of \$1,250 to the CMLD in order to balance out Fiscal Year 2011/12.

FIRE PREVENTION SPECIALIST SCOPE OF WORK- Accomplishment Report

Date: May 31, 2012

- 1. Increase cooperation and coordination between and among Plumas County Firesafe Council, Plumas County Fire Chief's Association, existing Fire Protection (or service) Districts, Plumas County Feasibility Study Group, and other fire prevention agencies by regularly attending meetings, providing updates, developing reports and providing wildland fire prevention information and knowledge as appropriate.**

Accomplishments:

- Attended the following meetings: Monthly Firesafe Council, Quarterly Fire Chief's Meetings, Plumas County Emergency Services Feasibility Group, Planning Commission Meetings.
- 2. Work with Plumas County Fire Safe Council to increase the number of Firewise Communities throughout Plumas County through education and outreach to the local fire departments, various community organizations and the public.**

Accomplishments:

- Work closely and coordinate activities with Jerry Hurley Fire Safe Council (FSC) coordinator.
 - Outreach to individual Fire Chiefs on opportunities in their Districts.
 - Working with FSC and Greenhorn Creek Community Services District who just received funding confirmation for a Community Wildfire Protection Plan (CWPP).
 - Met with Peninsula Fireman's Association on May 8 to present the Firewise Communities concept and collaboration with the Plumas Firesafe Council. 40 in attendance.
- 3. Provide wildfire prevention consultation and advise upon request to the Plumas County Planning Department, the Plumas County Planning Commission, and the Office of Emergency Services through review and comment on the draft Plumas County General Plan and the associated environmental document, and the county's Multi-hazard Mitigation Plan.**

Accomplishments:

- Attended Planning Commission Meetings. Met with Senior Planner Becky Herrin, Building Official John Cunningham to review materials and opportunities for fire prevention consultation and coordination with local fire departments.
- Reviewed and provided comment on SB1241, the bill dealing with fire hazard impacts and their mandated inclusion in county General Plans.
- Continued review of Plumas County's Draft General Plan and coordination with local fire agencies.
- Providing input to GIS Planner Becky Osborn on Fire District information technology via the web for the public.

- 4. Facilitate input from Plumas County Fire Departments regarding the Community Wildfire Protection Plan (CWPP) and Firewise Community development and assist Plumas County Fire Safe Council in coordinating, reviewing, and updating the CWPP.**

Accomplishments:

- Continue meetings with Fire Chiefs for one on one briefings and information sharing.
- Introduction to the WUI, Safety Element of General Plan, and CWPP.

- 5. Work with Fire Safe Council, local fire departments, community leaders and organizations to develop wildfire prevention strategies and mitigation measures.**

Accomplishments:

- One-on-one meetings with the following fire chiefs: Quincy, Indian Valley, Long Valley, Beckwourth, Eastern Plumas, Sierra Valley, Graeagle. Other meetings pending.
- Met with Graeagle Fire District Board. Meet with other Fire Boards of Directors as needed or opportunities arise.
- Field assessment with Indian Valley Fire Chief Hamblin and CALFIRE Captain Vargas for opportunities to provide FIREWISE education to the community of Genesee.
- Developing WUI Fire Season public service campaign for local newspapers.
- Coordinate fire prevention messaging activities with Forest Service Public Affairs Office, Fire Prevention Staff and CALFIRE for unified message.
- May 15 KQNC radio show Common Good. Shaping Firesafe communities.

- 6. Provide Quarterly updates to the Plumas County Board of Supervisors during a regularly scheduled and publicly held Board meeting.**

Accomplishments:

- June 5, 2012 planned update.

- 7. Develop an action plan to provide homeowner education and outreach for properties located outside existing fire protection district boundaries.**

Accomplishments:

- Coordinate seasonal activities with USFS and Cal Fire through Fire Safe Council.
- Coordinate with Tom Forster on messaging through "Inside the Firehouse" articles.
- Seek out opportunities to reach out to Homeowners Associations, Board of Realtors, community groups and others through print, radio, web based media and other means.

8. Develop a community-based plan that outlines steps to assist communities in obtaining fire protection coverage for currently uncovered areas.

Accomplishments:

- Met with Feasibility Group, County Assessor Chuck Leonhardt, and others to assist with Quincy Fire-Chandler Ranch area service agreement or possible annexation.
- Assist Graeagle Fire Department plan and organize community informational meeting for Blairsden residents and businesses outside the fire district boundary.
- Coordinate with John Benoit, LAFCo Executive Director, and local fire districts regarding fire district boundaries, spheres of influence, and planned annexations.
- Continued creation of a communication plan on the out of district issue. Includes background info, talking points, sample fees for services, sample meeting agenda, fire insurance options and information, etc.

Subject: Authorize Mileage Reimbursement for Members and Alternates of the
Plumas County Integrated Waste Management Task Force

Background:

At the April 5, 2012 meeting of the Plumas County Integrated Waste Management Task Force (Task Force), the Task Force members discussed the fact that mileage reimbursement is not presently authorized for members and alternates of the Task Force.

Based on testimony at the April 5th meeting, mileage reimbursement was previously available to the members of the Task Force during the time period that the Planning Department served as the staff liaison for the Task Force. When staff liaison responsibilities were transferred to Public Works, mileage reimbursement was eliminated for some unknown reason.

During the April 5th Task Force discussion, it was also suggested that mileage reimbursement may also encourage future volunteerism in serving as a Member or Alternate Member on the Task Force.

The following is extracted from the minutes of the April 5, 2012 meeting of the Task Force:

8-B. The Task Force discussed the fact that mileage reimbursement is not presently authorized for members and alternates of the Task Force. Testimony at the meeting asserted that mileage reimbursement was previously available to the members of the Task Force during the time period that the Planning Department served as the staff liaison for the Task Force. When staff liaison responsibilities were transferred to Public Works, mileage reimbursement was eliminated for some unknown reason. It was also suggested that mileage reimbursement may encourage future volunteerism in serving as a Regular or Alternate Member on the Task Force. Bob Perreault reports to the Task Force members that there are funds available to reimburse members and alternates for their mileage costs to attend the meetings for this fiscal year (at the approved IRS rate of \$0.55 per mile). A motion was made by Leslie Tigan, seconded by Tom Yagerhofer, and passed with a vote of 4-0, to recommend implementation of mileage reimbursement for regular and alternate members of the Task Force, to be effective immediately.

Financial Impact:

If the Board of Supervisors authorizes mileage reimbursement for the Task Force, retroactive to April 5, 2012, the anticipated cost to the FY2011-12 existing budget is estimated to be in the order of \$ 225.00. The amount that appears in the FY2012-13 proposed budget is \$ 1,000.00.

Recommendation:

Public Works staff respectfully recommends that the Board of Supervisors authorizes mileage reimbursement for the Task Force, at the approved IRS rate, as issued by the Auditor's Office, retroactive to April 5, 2012.

RECOMMENDED THAT THE BOARD:

Approve refilling of the Public Works 1.0 FTE Equipment Service Worker; and 1.0 FTE Power Equipment Mechanic. It is also recommended, that the .625 FTE Librarian position be temporarily filled by utilizing temporary help, until the 2012-2013 budget process.

BACKGROUND AND DISCUSSION

The Equipment Service Worker vacancy is due to a promotion of this employee to a Power Equipment Mechanic Worker I, on January 15, 2012. By having this position filled, the Power Equipment Mechanics can focus on the more technical mechanical issues. The Equipment Service Worker can take care of the less complicated shop tasks, such as oil changes and runner for parts. This position is allocated and funded through the Public Works Department; by refilling this position there is no impact or cost to the General Fund.

The Power Equipment Mechanic submitted his resignation after working approximately fourteen months. This position is necessary to ensure that the Public Works fleet is operational and in a safe and efficient condition. This position is allocated and funded through Public Works. The refilling of this position will have no impact or cost to the General Fund.

Due to the fact that there is no impact to the General Fund, it is the recommendation of this Committee to refill both the

positions of Equipment Service Worker, and the Power Equipment Mechanic.

On May 21, 2012, notice was provided to Interim Librarian Ms. Mitchell, informing that her .625 FTE Librarian at the Quincy Branch would be retiring as of June 2, 2012. After receiving the retirement notice, Ms. Mitchell completed the questionnaire to refill this position. The Committee recognizes that due to previous reductions in staff, the Library staff is stretched very thin. However, with the unknown financial stability of the General Fund; it is the Committee's recommendation for the Library to utilize temporary help to cover the duties of this position until the budget process has been conducted.

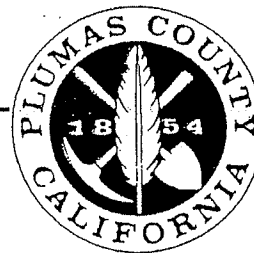
The Interim Librarian stated in the attached questionnaire, that the Library had funding within the budget under the other wages line item to cover the front desk; but not to perform the other duties of the position. After considering this factor, the Committee would also recommend that if the Library runs short within their other wage line item, that a transfer from regular wages be completed to cover the expense.

With the uncertainties of the funding for the General Fund, we believe that it is premature to hire someone in this position with the possibility that during the budget process the position may be reduced further or laid off.

RE: Equipment Service Worker Position

On January 15, 2012 the Department promoted the Equipment Service Worker to a Power Equipment Mechanic Worker I position.

The Department would like to fill the vacant Equipment Service Worker position. This is a valuable position in the mechanic shop. It allows the skilled mechanics to continue working on the more technical mechanical problems while the service worker takes care of the less complicated shop tasks, parts runner, etc.

This position is allocated and funded within the Road Department Budget.

Attached is a completed "Questions for Staffing Critical Positions Which are Currently Allocated."

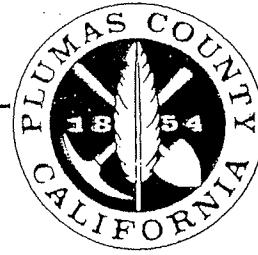

AN ORDINANCE OF THE COUNTY OF PLUMAS, STATE OF CALIFORNIA,
REZONING CERTAIN REAL PROPERTY TO ADD THE FARM ANIMAL COMBINING ZONE (F)

The Board of Supervisors of the County of Plumas, State of California, ORDAINS as follows:

Section 1. Creation of Zone.

The following real properties, as depicted in Exhibit "A", are hereby rezoned to add the Farm Animal Combining Zone (F) as the terms are described in the Plumas County Code, retaining the Single Family Residential (2-R) zone as it currently exists.

The real properties herein described are located at 2536, 2538, 2540, 2542, 2544, and 2548 Rideout Trail, Greenhorn Ranch, Plumas County, CA; more particularly described as Assessor's Parcel Numbers 009-300-034, 009-310-011 and 009-310-044; T24N/R11E/Section 33, MDM.

Section 2. Zoning Plan Maps.

The Plumas County Planning Director is hereby directed to reflect the zoning as provided for in this ordinance and pursuant to Section 9-2.302 of the Plumas County Code.

Section 3. Codification.

No sections of this ordinance shall be codified.

Section 4. Publication.

Item Description/Recommendation: Approve a Resolution Amending the 2011-2012 County Personnel Allocation in Public Health Budget Units 70560 and 70559 due to changes in grant approved budgets, Effective April 1, 2012.

The NECCC and UCCC Consortia Project: An Executive Summary of the FY 2012 Work Plan

I. Introduction

CENIC, the Corporation for Education Network Initiatives in California, was recently awarded two planning grants from the California Public Utilities Commission (CPUC) to manage the work of two consortia over the next three years--the Northeastern California Connect Consortium (NECCC) and the Upstate California Connect Consortium (UCCC). The CSU Chico Center for Economic Development is CENIC's management partner. The Sebastian Corporation has been contracted to assist in developing the technical infrastructures plans that are needed.

There are 16 rural counties in Northern California---**Butte, Colusa, Del Norte, Glenn, Humboldt, Lake, Lassen, Mendocino, Modoc, Plumas, Shasta, Siskiyou, Sonoma, Tehama, Trinity, and Yolo**--without a comprehensive, integrated, open access, regional middle-mile that interconnects these counties, and comprehensive last-mile broadband infrastructures serving the communities in these counties. These two consortia are focused on 11 (in bold face) and are cooperating with the Redwood Coast and Capital consortia to develop and implement a ***Northern California Broadband Plan (NCBP)***.

II. Mission, Vision, Strategic Planning Framework, and Goals

A. Mission

It is the mission of NECCC and UCCC to develop and facilitate the implementation of a broadband infrastructure plan that will provide a cohesive, integrated and robust regional middle-mile and countywide Backbone Systems and community last-mile network infrastructure that will interconnect 11 of these counties in North California (Butte, Colusa, Lake, Glenn, Lassen, Modoc, Plumas, Shasta, Siskiyou, Sonoma and Tehama) together for the first time. At the same time, NECCC and UCCC will coordinate efforts with two other regional groups charged with planning for the other five counties to develop and implement a plan for a comprehensive and cohesive infrastructure that will encompass all 16 counties. In essence, the goal is to develop and begin to implement a ***Northern California Broadband Plan (NCBP)***.

B. Vision

The Vision of this project is to facilitate the presence and vigorous use of broadband access, at the **National Broadband Plan** minimum standards (100 Mbps download and 50 Mbps upload), for all individuals living, working and going to school in Northern California.

C. Strategic Planning Framework

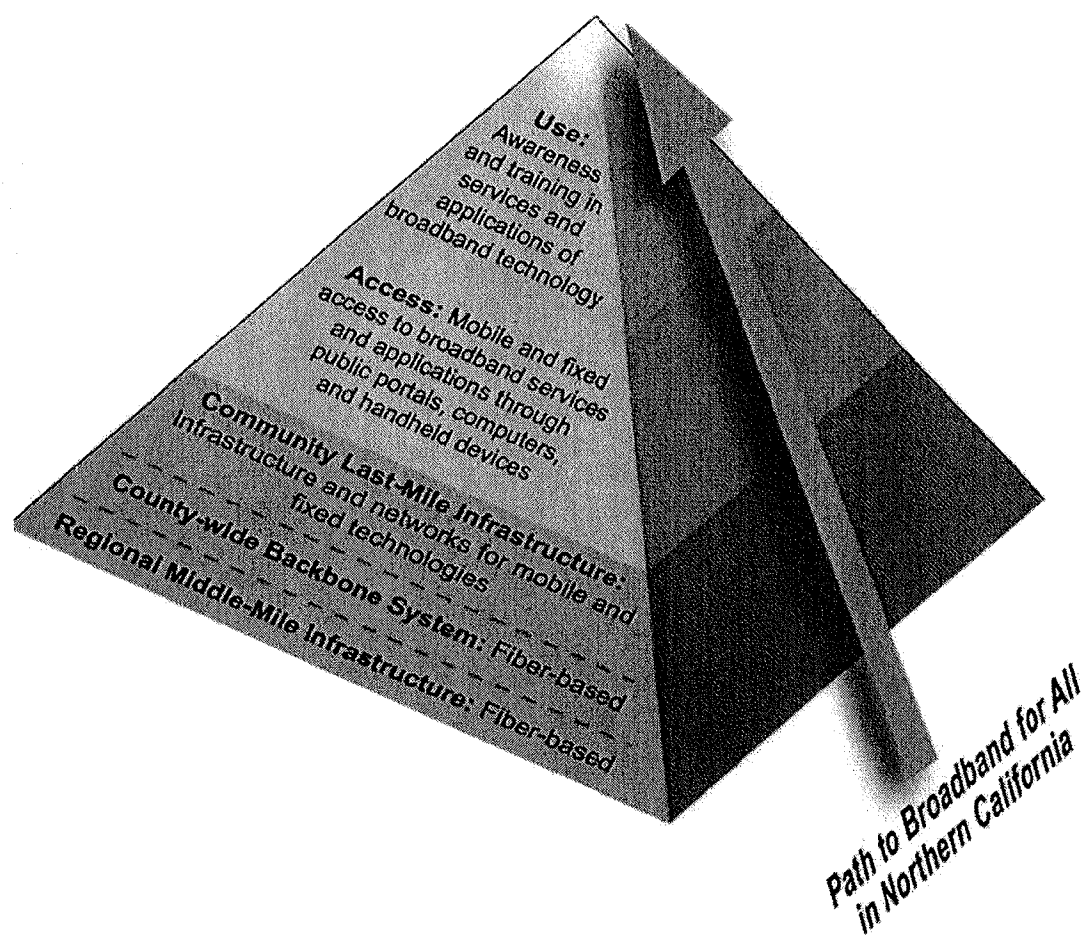


Figure 1: Building Blocks to Broadband in Northern California

Figure 1 below depicts the building blocks and path to achieving access to broadband for all in Northern California. As shown, at the foundation there must be a comprehensive integrated Regional Middle-Mile Fiber-Based Infrastructure across the 16 counties with the capacity needed today and the growth potential for the long-range future.

As a second tier of this foundation fiber-based infrastructure there needs to be a Countywide Fiber-Based Backbone System that reaches each of the incorporated communities and as many unincorporated communities as possible. Each County Backbone System must be linked into the Regional Middle-Mile Infrastructure at multiple points to provide diversity.

Once the blueprint for this two-tiered foundation infrastructure is known, meaningful deployment of this foundation can begin; planning and deployment of community last-mile infrastructures also can be launched with assurance that end users will ultimately have robust connectivity to the worldwide Internet.

Full and comprehensive access from any location within the i6 counties will only be available when the regional and county infrastructures are completed and in place. In the meantime, a wide range of temporary strategies and solutions need to be implemented to maximize access for the greatest number of individuals.

While the primary thrust is to develop comprehensive plans for a regional middle-mile infrastructure, countywide backbone systems and last-mile community networks, it will also

vigorously pursue expanding access and training to increase adoption.

Once deployment of a Regional Middle-Mile Infrastructure is completed and countywide backbone systems are in place, last mile providers may then begin offering more choices at higher speeds, with more affordable costs to the end users. Only then will people be in a position to realize the benefits and relevance of broadband, ultimately purchasing monthly subscriptions. Increase in adoption leads to sustainable networks. Thus, our three-year plan is designed to follow the building blocks as depicted in Figure 1, starting with the major focus on the base of the pyramid.

D. Goals

The overarching goal of this project is to meet the current and long-term middle-mile and last-mile broadband needs of the 1,633,967 citizens living in these 16 counties. Within this overarching goal is a key objective to directly connect 109 major anchor sites to this regional middle mile backbone via direct fiber connections. By category these anchor sites breakout as follows:

- 20-K12 County Offices of Education Sites
- 14-Community College Districts/College Sites
- 3-CSU Campus Sites
- 16-Major/County Library Sites
- 16-County Central Public Safety Answering Point Sites
- 40-Major Health Delivery Facility Sites

Exhibit #1 provides a list of these potential anchor sites.

A second key objective is to use the middle-mile infrastructure to help meet the needs and requirements for last-mile connectivity by local, county, state, and federal agencies, businesses and residences, especially in the unserved and underserved areas in these four counties. Also, via last-mile connections to this middle mile infrastructure K-12 schools, branch libraries, secondary public safety answering points, and a range of health facilities will enhance their connectivity to their respective anchor institutions in the county.

III. Work Plan for FY 2012

There is a detailed Work Plan for each of the three years of the project. The following is a summary of the tasks and deliverables for this year's work plan.

FY 2012 (Year 1) Tasks

- One primary focus of this project over the first year will be to develop the Regional Middle Mile Conceptual Design for the broadband infrastructure plan that will provide a cohesive, integrated, and robust regional middle-mile and countywide backbone and last-mile network infrastructure that will interconnect the 16 Northern California counties.
- As an integral part of this development, the current telecommunications providers will be engaged to learn of their current middle- and last-mile offerings and future plans to deploy broadband to the communities they serve; determine their interest in cooperating in this project; and to assess whether their assets can be utilized as part of the Conceptual Design.

- At the same time, it will be important to assess the environmental issues that will need to be addressed to turn the Regional Middle-Mile Infrastructure Conceptual Design into a real network infrastructure.
- By developing a viable Regional Middle-Mile Infrastructure Conceptual Design, the stage will be set to maximize investments in future deployment while reducing redundant efforts and lowering costs for deployment as well as costs to the end users for services.
- A second primary focus of the project will be to develop a Countywide Backbone System and Community Last-Mile Conceptual Design for each County.
- A third primary focus will be to facilitate the identification and/or creation of entities to take the leadership in doing the detailed planning and implementation of these conceptual design plans.
- Work with special groups-K12, Libraries, Public Safety and Health delivery to develop specific networking plans for these groups across the 16 counties.
- While the project intends to give primary attention to developing the conceptual designs for the Northern California Broadband Plan, equal effort will go into engaging, informing, expanding awareness, gaining support, and securing commitment to this effort from all facets of the communities.
- During the first year, we also will concentrate on updating the status of access in each county and assessing the status of training and adoption programs available across the aforementioned counties.
- Finally, this project will collaborate with the other Regional Consortia to make sure all parties are committed to the overall Northern California Broadband Plan.

FY 2012 (Year 1) Major Deliverables

- Deliverable #1** Ensure a widespread awareness, buy-in and commitment to the consortium's mission by conducting consortium and county meetings and by sharing information over the web and through the quarterly reports.
- Deliverable #2** Produce a written Regional Middle-Mile Conceptual Design Plan.
- Deliverable #3** Produce a comprehensive written Countywide Backbone Systems and Community Last Mile Conceptual Design Plan for each of NECCC and UCCC counties.
- Deliverable #4** Ensure the formation of an entity to take the lead in planning and developing the Regional Middle-Mile Infrastructure.
- Deliverable #5** Ensure the identification of an entity to take the lead in planning and deploying broadband in each of the UCCC counties.
- Deliverable #6** Develop a report identifying currently available last-mile capabilities in each county and evaluate their potential to meet the Conceptual Design.
- Deliverable #7** Prioritize the unmet last-mile access needs in each county.
- Deliverable #8** Issue a report assessing the availability of adoption programs in each county.
- Deliverable #9** Work with county and municipal governments to adopt policies and regulations that will promote deployment and use of broadband.
- Deliverable #10** Produce a joint written report with other regional consortia to ensure there is a Regional Middle-Mile infrastructure Plan ready for implementation throughout Northern California.

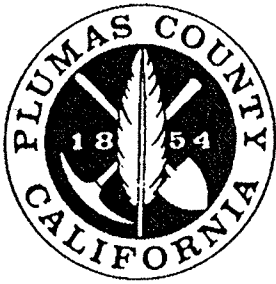

Recommendation:

Please approve the applications and resolutions for the Workers' Compensation Insurance Fraud (WCF) and the Automobile Insurance Fraud (AIF) Grants offered by the California Department of Insurance for \$9,518 and \$5,070 respectively.

Background and Discussion:

In July of 2011, the Board approved the Resolutions for two grant applications for 2011-12 submitted to the California Department of Insurance (DOI): Workers' Compensation Fraud and Automobile Insurance Fraud. For 2011-12 only the Workers' Compensation Fraud grant was awarded for \$6,000. The funding for these grants comes from insurance premiums, not the state general fund.

Although these two grants were formerly received by the District Attorney's Office from 1996-2005, there was little activity due to low levels of fraud detected. Since that time, the Department of Insurance Fraud Division has expanded their investigative resources to detect more insurance fraud. They have been working closely with the District Attorney's Investigators to refer suspected cases for local investigation. Since the Fraud Division now receives suspected referrals from insurance companies and the public, a more effective system has been developed and more prosecutions are anticipated.

The impact of unaddressed insurance fraud has the ability to hurt the local economy by drawing economic resources away from businesses, by increasing the costs of insurance for everyone and by demoralizing those people whose businesses and lives are affected. When resources available for legitimate economic activities are drawn away by fraud, employment levels suffer and the entire economy declines. In a small close-knit

community such as this, the loss of jobs is keenly felt by merchants, other businesses and schools. Government agencies providing assistance to the unemployed and underemployed have resources spread over more people and are less able to help such populations further impacting the local economy.

It is for these reasons that the District Attorney's Office applied for these two grants from the Department of Insurance and is making the commitment to direct investigative resources towards these critical problems. Although the Automobile Insurance Fraud grant was not awarded for 2011-12, resources existing in the District Attorney's Office have been applied to all suspected fraud cases referred by the DOI Fraud Division and we are applying to this grant as well this next fiscal year.

The only costs in the applications are for an FTE of only 0.03 in WCF or about sixty-three hours per year for the Senior Investigator. The AIF application includes an FTE of 0.02 or about forty-two hours per year. Also the applications include training for the Senior Investigator and the Investigative Assistant. No administrative costs were requested.

The training for Fraud Investigation has been developed by the California District Attorney's Association in conjunction with the Department of Insurance. It is focused on Insurance Fraud but other forms of fraud are also covered, which will enhance the District Attorney's ability to investigate and prosecute other fraud.

Personnel for fraud investigation are being redirected from some other grant funding that has been eliminated so no supplanting is taking place.

The Resolutions are attached. Copies of the applications are on file with the Clerk of the Board. The budgets for these programs have been submitted with the Requested Budgets turned in to the Auditor's Office for 2012-13.

The County Counsel's Office has approved the Resolutions as to form.

It is Recommended that the Board of Supervisors

1. Accept a bid from Environmental Alternatives, Inc. for the provision of training to relatives and non-relative extended family members who have children placed with them.
2. Authorize the Department of Social Services to execute a contract with Environmental Alternatives with a planned effective date of July 1, 2012 or as soon thereafter as administratively feasible.

Background and Discussion

The Board of Supervisors is aware that the Department of Social Services has (for the past six years) been engaged in an Outcome Improvement Process for Child Welfare Services (CWS). Federal and state laws require the Department to prepare a triennial CWS System Improvement Plan (SIP). In April 2011 the Department prepared and your Board approved the third triennial System Improvement Plan for Plumas County's Child Welfare Services program. The plan was prepared based on significant input from our community based and public agency partners. This collaborative process assisted the Department in identifying strengths and challenges in our CWS system and helped us select and prioritize outcome areas that would be targeted for improvement.

Among the recommendations that were identified in the 2011 SIP process was a strategy targeted to improving the stability of placements for children who are removed from their homes. As elements of that strategy, the following specific goals were included in the 2011 System Improvement Plan.

- Increase the number of children who are placed with their relatives.
- Provide training and other supports to foster parents, relatives and non-related extended family members.

During the past six years the Department has increasingly sought out relatives and non-related extended family members for placing abused and neglected children. We have reached a point now where last year half or more of the children removed from abusive homes were placed with relatives or non-related extended family members so we are making good progress on that element of our strategy to improving placement outcomes.

In an effort to move the second goal of providing training and other supports to family members and non-related extended family members who have children placed with them, the Department solicited bids for such support and training from qualified community based entities in early April of this year. Two bids were received by the Department. A bid from Mountain Circle Family Services was received for \$75 per hour plus \$.50 per mile for travel outside of Plumas County. A second bid was received from Environmental Alternatives for \$20 per hour. This bid price includes any transportation costs even for travel outside of the county.

Each of the bidders has a business presence in the County. The Department expects that during FY 2012-2013 as many as 20 relatives will require this 10 hour training program. The annualized cost for Mountain Circle services would be \$15,000 plus mileage costs for travel outside the county compared to \$4,000 for Environmental Alternatives. In consideration of the significant difference in cost, the Department recommends accepting the Environmental Alternatives bid.

County Counsel has prepared a draft agreement for our use for this project. The Department is also requesting that we be given authority to execute the contract on the Board's behalf.

Other Agency Involvement

The Office of County Counsel reviewed the request for bids prior to its issuance and has also prepared a draft contract for our use in relationship to this project.

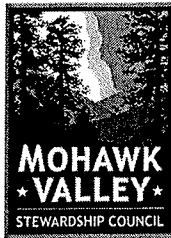

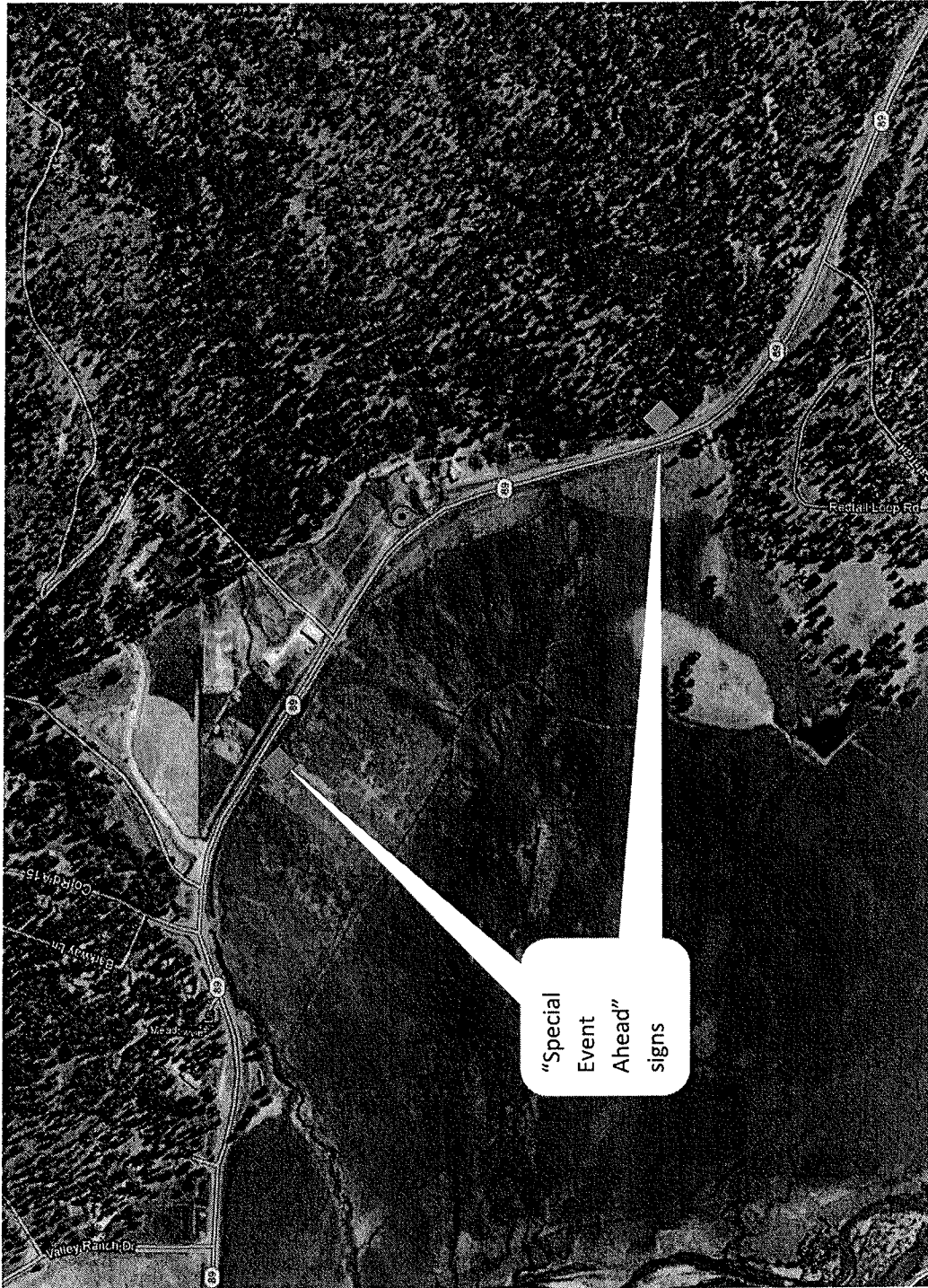

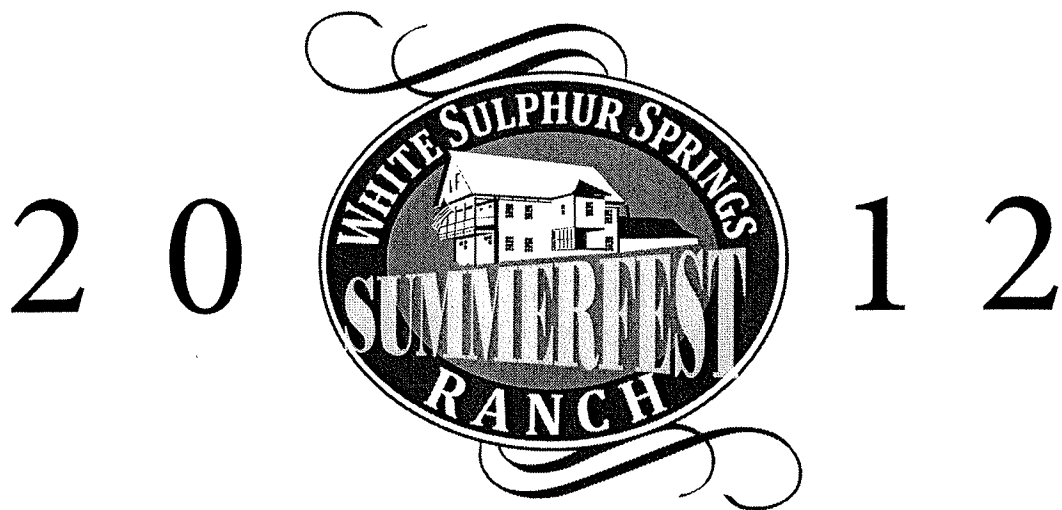

Background:

On May 1, 2011, Contract No. PWSW11-010 was executed with Taylor Electric for the installation of a new 100 amp/3 phase meter main panel w/12/24 circuit capacity, relocation and replacement of control panel for the compactor with new switch, hydraulic pump switch, compactor ram control switch, and installation of emergency shut-off switches for operator safety, in the contract base amount of \$6,900.00. There were several "call-backs" for the contractor to come to the site and resolve the issues between the electronic controls and the operation of the hydraulic ram system, which effort was interrupted when the hydraulic ram broke and had to be removed from the system to a shop in Reno where it was repaired. Change Order No. 1 was issued on December 27, 2011 for \$2,138.00 for that extra work

Thereafter, when the ram was repaired, there was still a need to integrate the hydraulic and electrical systems. Change Order No. 2, for \$1,930.92, represents the contractor's time and materials to finalize the system controls and install limit switches on the hydraulic ram to prevent the ram from overextending in either direction. This Change Order has been approved as to form by the County Counsel and approved by the Director of Public Works under his authority as Road Commissioner.

The work has been conducted to the satisfaction of Public Works staff and was deemed to be complete on March 15, 2012.

The Contractor has submitted as-built schematics and other documentation to Public Works and the franchise contractor.

Recommendation by Public Works:

It is respectfully recommended that the Board of Supervisors ratify the work approved by the Director of Public Works, retroactive to December 27, 2011.
