#### **ROLL CALL**

The meeting is called to order at 10:00 a.m. with Supervisors Terry Swofford, Lori Simpson, Ole Olsen and Chair Sharon Thrall present. Supervisor Robert Meacher is absent.

#### **1. COUNTY ADMINISTRATIVE OFFICER**

##### **A. OFFICE OF EMERGENCY SERVICES**

##### **EMERGENCY SERVICES FEASIBILITY GROUP - ESTABLISH**

Following a report from Kelly Stane, Interim OES Director, and discussion by the Board, motion by Supervisor Olsen, second by Supervisor Swofford, and carried to take formal action to establish the Plumas County Emergency Services Feasibility Study Group.

##### **CHANGE OF PUBLIC OFFICE HOURS**

Sheryl Austin, Veteran's Service Officer, presented her request for the change of office hours.

Discussion followed. Motion by Supervisor Olsen, second Supervisor Simpson, and carried to adopt new public office hours for the Veterans Service Office as Tuesdays, Wednesdays and Thursdays from 9:00a.m. to 4:00p.m.

##### **EXTRA HELP ON-CALL EMPLOYEES**

### **4. PLUMAS SIERRA COUNTY FAIR BOARD**

Motion by Supervisor Simpson, second by Supervisor Meacher, and carried to appoint Kenny Chance as a Director to the Plumas Sierra County Fair Board – District 4. Discussion followed with Supervisor Simpson disclosing that Back Door Catering, owned and operated by Karen Chance, wife

of Kenny Chance, operates on the Plumas-Sierra Fair Grounds. She noted that Mr. Chance would recuse himself from any matter regarding the Fair and Back Door Catering.

**3. MENTAL HEALTH COMMISSION – Hank Eisenman**

Mr. Eisenman, Chairman of the Mental Health Commission, and John Sebold, Director of Mental Health, gave their presentation of the annual report of the Mental Health Commission for fiscal year 2007-2008. They stated their emphasis will be on pursuing prevention planning, and Mr. Sebold praised the commission members for their work and dedication. The Board complimented their efforts and work accomplished.

**4. LASSEN NATIONAL FOREST**

Chris O'Brien, Public Information Officer for Lassen National Forest, gave a report and briefing to the Board regarding Lassen National Forest's Travel Management Draft Environmental Impact Statement (DEIS). He stated they were trying, with this management draft, to anticipate the needs of various groups regarding the road system in the forest. The Board thanked him for keeping Plumas County informed.
