**RESOLUTION OF THE BOARD OF SUPERVISORS OF THE COUNTY OF PLUMAS
PROCLAIMING A LOCAL EMERGENCY IN PLUMAS COUNTY DUE TO
EXCESSIVE HEAT**

RESOLUTION 2021- 8600

WHEREAS, beginning on July 9, 2021, a heat wave is expected to hit Plumas County bringing temperatures in excess of 100 degrees to the County; and

WHEREAS, the National Weather Service has issued an Excessive Heat Warning for portions of Plumas County beginning July 9, 2021 at 12:00 p.m. until July 12, 2021 at 9:00 a.m.; and

WHEREAS, the Excessive Heat Event is expected to last through at least July 12, 2021; and

WHEREAS, many residents of Plumas County are without air conditioning or other adequate means of cooling their homes, and

WHEREAS, the Board of Supervisors find the Excessive Heat Event constitutes a local emergency and emergency situation as set forth in California Government Code sections 8630 and 54956.5; and

WHEREAS, the aforesaid conditions of extreme peril warrant and necessitate the Proclamation of the Existence of a Local Emergency; and

WHEREAS, these conditions are likely to be beyond the control, capacity, and resources of the services, personnel, equipment, and facilities of Plumas County, and local resources are unable to cope with the effects of said emergency; and

WHEREAS, the aforesaid emergency necessitates the immediate expenditure of public monies to protect health, safety and property without complying with competitive bidding and other local purchasing, bidding, and procurement requirements.

NOW, THEREFORE, BE IT RESOLVED, that the Board of Supervisors of the County of Plumas, State of California, hereby Proclaims that a local emergency now exists throughout Plumas County due to the Excessive Heat Event.

BE IT FURTHER RESOLVED, that the Board of Supervisors of the County of Plumas, State of California hereby directs that:

1. This Proclamation of Existence of a Local Emergency shall be renewed and deemed to continue to exist as provided by state law or until its termination is proclaimed by the Board of Supervisors of the County of Plumas.
2. The Director of Emergency Services for the County of Plumas is hereby designated as the authorized representative of the County of Plumas for the purpose of receipt, processing, and coordination of all inquiries and requirements necessary to obtain available State and Federal assistance.
3. During the existence of said local emergency, competitive bidding and other local purchasing, bidding, and procurement requirements related to the Local Emergency are suspended.
4. The Director of Emergency Services or his designee immediately forward a certified copy of this resolution proclaiming a local emergency to the Governor of California with a request that the Governor continue to maintain a State of Emergency for the County of Plumas.
5. During the existence of said local emergency the powers, functions, and duties of the Director of Emergency Services, or his designee, and the emergency organization of the County shall be those prescribed by state law, local ordinance and resolutions of this county as approved by the Board of Supervisors.
