

RESOLUTION NO. 22-8752

A RESOLUTION OF THE PLUMAS COUNTY BOARD OF SUPERVISORS AUTHORIZING THE PLUMAS COUNTY SHERIFF TO (1) CONTRACT WITH THE CALIFORNIA DEPARTMENT OF CORRECTIONS AND REHABILITATION (CDCR) UNDER CDCR CONTRACT NUMBER C5611148, (2) EXECUTE CALIFORNIA DEPARTMENT OF CORRECTIONS AND REHABILITATION AGREEMENTS, AND (3) AMEND THE AGREEMENT AS REQUIRED.

WHEREAS, the County of Plumas and the California Department of Corrections and Rehabilitation desire to contract under agreement number C5611148; and,

WHEREAS, the California Department of Corrections and Rehabilitation will provide confinement and supervision for inmates confined Plumas County Correctional Center inmates in accordance with an order from the Superior Court judge; and,

WHEREAS, the California Department of Corrections and Rehabilitation requires the Board of Supervisors to adopt a resolution authorizing a single Contractor to sign the aforementioned agreement; and,

WHEREAS, the need to have a higher level of care for inmates housed at the Plumas County Correctional Center is critical to the health and safety of Plumas County Correctional inmates, and it is to the County's benefit to authorize the Plumas County Sheriff to take such actions without delay.

NOW, THEREFORE BE IT RESOLVED that the Board of Supervisors of the County of Plumas, State of California:

1. Authorizes the Plumas County Sheriff to accept and bind the County to any and all agreements and amendments relating to California Department of Corrections and Rehabilitation Agreement Number C5611148 to a maximum amount of \$67,144.00 (Sixty-Seven Thousand, One Hundred and Forty-Four Dollars and Zero cents) for the life of the agreement which terminates on June 30, 2024.
2. Authorizes the Plumas County Sheriff to execute any and all Agreements and other documentation necessary to apply for and accept the agreement, subject to approval as to form by the Plumas County Counsel
