- Mike working on paperwork/logistics

COVID-19: Dr. Satterfield

- Increase in COVID cases and seeing a slight increase in hospitalization in late July
- Long COVID is hot topic with 2nd COVID seems to be worse especially in high-risk populations.
- Test to treatment going well in Plumas Co with Paxalovid available in Plumas Co
- Do not have to have renal test to be prescribed Paxalvoid, but at discretion of provider, may look at medical history
- Positive home test good enough to be prescribed Paxalovid

HeartSafe Community

- Update from Central Plumas
 - Working on continued AED tracking
 - Recognition ceremony for first responders who assisted with 2 saved cardiac arrests: One of the lives saved was at the ceremony
- Letter of Intent received from EPHC Ambulance:
 - No update
- Lake Almanor Area:
 - AED for RV Park- Lake Cover needs to be installed

Health Care Coalition (Tri-HCC):

- Next meeting scheduled for August 3, 2022

PCSO- Communication Update: Mike Grant and Becky Grant

- All 10 med comms are licensed for all repeaters
- Network failure on Beckwourth for couple hours
- Plumas Sierra Rural Telecommunications took EMS repeater. Who approved?
- Zonehaven: Platform for evacuation information for public. Currently 120 zones. Each hospital has their own zone
- There will be a PSA campaign once Zonehaven is up and running. Want public to know their zone. Code Red alters will use Zonehaven zones
- Concerns regarding transferring medical 911 calls to hospitals. Issues of no one at hospital answering phone. There is some discussion of all medical calls being transferred to REMSA dispatch; however, this will take some time to implement.

- Issues with on-scene responders (mainly fire) requesting specific air ambulance. Dispatch will determine which air ambulance will respond, based on closest/fastest response
- Issues with Cal-Fire and communication, mainly when Cal-Fire responds in the canyon. There is a lack of communication from Cal-Fire with SO dispatch. There has been a lot of turn-over in Cal-fire, which may be part of the cause
- SO dispatch still hiring

Agency Reports:

- Peninsula Fire- Andrew: 4th of July went well, still some cell disruptions (have not returned to normal since Dixie Fire), still looking for staff, finish up Emergency Broadcast System still dealing with PG&E hoping to address after fire season
- EPHC Ambulance-Amy: Thankful to Becky for letting her know of the communication issues regarding medical calls so it can be addressed, sprinkling of COVID positive among staff but spaced out so not unmanageable, very busy
- Air Methods- Louie: Staffing issues, but otherwise good
- Seneca-Linda: Some COVID issues with staff, but not huge, filling shifts due to vacation, overall doing well, with some minor disruptions of services for SNF due to various projects
- PDH-Darren: Same as EPHC and Seneca, searching for a home for EMS in Indian Valley/Greenville, possible joint building with fire and SO, but that would take a while, so maybe a rental for now
- REMSA/Careflight- Matt: Some staffing issues but overall maintaining
- EPFRD-Elaine: quiet, but trying to get ready for fire season- status quo
- PC OES- Pam: status quo
