Update from Nor-Cal EMS

- Mike Loew was introduced and will be working closely with Mark Thomas
- “ImageTrend” is an EMR platform for EMS, which Cal EMS is in the process of utilizing. Fire Departments may be able to use for their required reporting. However, there may be a fee to use the system

HeartSafe Community

- Central Plumas: Sam is working with LeTina from Sierra County allowing Siera County to use Plumas County’s Pulse Point App to register their AEDs
- Lake Almanor: No updates
- Eastern Plumas: A Letter of Intent has been submitted July 2023. EPHC is working with Sierra County to achieve the HeartSafe Community acknowledgement for their communities. Sam will be contacting them to provide some guidance.

Training:

- AirVo2: Sam is in the process of scheduling training for AirVo2 (high flow nasal cannula)- there will be a training for Chester Fire/Peninsula Fire. Once training is complete Sam will place an AirVo2 at Seneca Hospital. There will be a training for EPHC and Careflight with the other unit held at PDH
- Warm Zone policy and training: Sam is working on an EMS warm zone policy which should be completed in August. There will be a training for Careflight with SO on August 2nd. Another training will be held with all EMS providers on August 16th. This does NOT apply to volunteer firefighters/EMS, only to local ambulance providers (Chester Fire, Peninsula Fire, Care Flight and EPHC ambulance).
