The violations alleged are:

Conflict of Interest in Public Contracts (GC 1090)

N/A

I am writing to file a formal complaint against Adam Cox, General Manager of the Chester Public Utility District (CPUD), and the CPUD Board of Directors for conflict of interest in public contracts and other serious misconduct.

1. Conflict of Interest in Contractual Obligations: In 2023, Mr. Cox was concurrently contracted in four separate districts, including CPUD, without appropriately disclosing his other professional commitments. This non-disclosure raises significant conflict of interest concerns, especially given that his contract with CPUD stipulated a 30-hour work commitment per week in Chester.

2. Failure to Fulfill Contractual Hours: Witness accounts suggest that Mr. Cox rarely fulfilled his contractual obligation of 30 hours per week at CPUD. This neglect not only breaches his contract but also deprives the district of the managerial oversight it requires.

3. Concealment of Communications: Mr. Cox has a documented pattern of concealing crucial communications that could potentially lead to his removal. This includes hiding applications received by his search firm for positions at CPUD and ignoring or misplacing citizen complaints, effectively obstructing due process.

4. Refusal to Address Complaints and Use of Board as a Barrier: Mr. Cox systematically refuses to address complaints, instead using the board as a barrier against legitimate citizen grievances. This behavior undermines the accountability mechanisms essential in public administration.

5. Unprofessional Communication and Evasive Tactics: Mr. Cox routinely engages in unprofessional and dismissive communication, often evading complaints through bureaucratic red tape. Examples include losing letters, instructing that formal emails should have been phone calls, and vice versa, thereby hindering effective communication and resolution of issues.

These actions by Mr. Cox, abetted by the CPUD Board's failure to effectively oversee and rectify these issues, constitute a gross violation of the ethical standards expected in public service. They not only undermine the operational effectiveness of CPUD but also erode public trust in the institution.

I urge your office to thoroughly investigate these allegations and take appropriate action to ensure accountability and rectification of these serious governance failures. The community of Chester deserves a public utility district that operates with integrity, transparency, and a commitment to serving the public interest.

Enclosed are supporting documents and witness statements corroborating these claims. I am available for further discussion or to provide additional information as required.
