**APPROVE RESOLUTION TO AMEND FISCAL YEAR 2025-2026 PLUMAS COUNTY
POSITION ALLOCATION FOR THE DISTRICT ATTORNEY, BUDGET UNITS #70301 AND
#20432**

WHEREAS, Plumas County Personnel Rule 5 provides amendments to be made by resolution of the classification plan covering all positions in the County service; and

WHEREAS, during the fiscal year needs may arise to amend the Position Allocation; and

WHEREAS, the District Attorney Department is requesting to amend their position allocation to flexibly allocate the current Fiscal Officer I/II, or Grant Compliance Officer position to Fiscal Officer I/II, or Grant Compliance Officer **or District Attorney Administrator/ Asst. Public Administrator**, and amending the position allocation for District Attorney Administrator/Asst. Public Administrator OR Paralegal I/II/III OR Legal Services Assistant I/II OR Legal Secretary-Trainee/Legal Secretary/Legal Secretary - Senior to Paralegal I/II/III OR Legal Services Assistant I/II OR Legal Secretary-Trainee/Legal Secretary/Legal Secretary - Senior; and

WHEREAS, this request was brought to the attention of the Interim Human Resources Director who is now requesting approval of this resolution to amend Plumas County's 2025-2026 Position Allocation to flexibly allocate the current .8 FTE Budget Unit 70301 Fiscal Officer I/II, or Grant Compliance Officer position to .8 FTE Fiscal Officer I/II, or Grant Compliance Officer **or District Attorney Administrator/ Asst. Public Administrator**, and the .2 FTE Budget Unit 20432 Fiscal Officer I/II, or Grant Compliance Officer position to .2 FTE Fiscal Officer I/II, or Grant Compliance Officer **or District Attorney Administrator/ Asst. Public Administrator**, and amend the flexible 3 Budget Unit 70301 FTE District Attorney Administrator/Asst. Public Administrator OR Paralegal I/II/III OR Legal Services Assistant I/II OR Legal Secretary-Trainee/Legal Secretary/Legal Secretary - Senior to 3 FTE Paralegal I/II/III OR Legal Services Assistant I/II OR Legal Secretary-Trainee/Legal Secretary/Legal Secretary - Senior.
