MINUTES  
November 17, 2025

Meeting of the Plumas County Transportation Commission (PCTC) called to order by Commission Chair Morton with roll call at 1:30 PM in the Conference Room of the Plumas County Public Works Department on November 17, 2025.

**1a. Roll Call**

Roll call was conducted by Rob Thorman, Director Public Works.

The commissioners present were Pat Morton, Jeff Engel, Susan Scarlet, and Bill Powers. Mimi Hall and Tom McGowan were absent.

**1c. Public Forum – Commissioners and Staff**

Commissioner Powers

- 1) State Route 70 Chalet View improvements – positive comments
- 2) Traffic control in Portola (State Route 70) – room for improvement
- 3) Annual question – Why are the Beckwourth and Massack rest stops closed?  
Highway rest stops on 44, 80 and 395 are open. Azeddine Bahloul reported that the rest stops in Plumas county do not have heat to prevent water from freezing.

Commissioner Engel

- 1) Pothole upkeep on State Route 70 should be maintained and monitored.

Azeddine Bahloul - Caltrans

- 1) Caltrans has met with the Portola City Manager and contractor to discuss traffic control and a sewer manhole issue. Meeting in advance of work will be helpful in moving forward.
