BUDGET BRIEFING

Mimi Hall, Director of Public Health Agency addresses the Board regarding unfilled positions in her department. Ms. Hall is concerned that if the positions are not filled, there will be an impact on contracted programs. Ms. Hall requests the Board consider issues facing county departments on a case-by-case basis.

Jack Ingstad, County Administrative Officer addresses the Board with a report and update on the FY 2008-2009 budget process. Mr. Ingstad continues to meet with the County Auditor, Labor Attorney and various Department Heads on a daily basis. Mr. Ingstad believes that due to unknown budget issues facing the county, it is important to move cautiously and informs the Board that he will not make a recommendation until he is confident it is the best decision for the communities and the county. Mr. Ingstad disagrees with the request from Ms. Hall to address issues on a case-by-case basis and recommends the Board not make any decisions until they receive complete and accurate information.

Canyon Complex Fire

Report and update by the US Forest Service regarding the Canyon Complex fire. Approximately 18,581 acres have been consumed; resources include 1,213 personnel and containment is approximately 64%. The Cold Fire is contained.

Reverse 911 Grant

Status report by Kelly Stane, Interim OES Director on the Reverse 911 Grant. The deadline to complete the grant and have the Reverse 911 system in place is September 28, 2008. The plan is to interface with the Sheriff's 911 dispatch system. Upon completion, the County will receive \$147,000.

US FOREST SERVICE – MOONLIGHT/WHEELER HARVESTING

Report and update by the Plumas National Forest regarding the Antelope Complex and Moonlight Fires post-fire recovery status. The fires burned approximately 88,000 acres in 2007. Alice Carlton and Mike Donald, representing the US Forest Service are present and address the Board. The project is the number one priority for Plumas National Forest. The proposed project includes tractor, skyline & helicopter salvage, and reforestation. The Notice of Availability of the Draft EIS was published on June 27, 2008. The public comment period ends on August 11, 2008. The final EIS decision is planned for September 2008 with award soon after. The total anticipated volume from roadside hazard plus salvage is approximately 101 MMBF.

ATTORNEY MICHAEL JACKSON, RENEW SERVICES AGREEMENT
