VI. PLANNING DIRECTOR'S REPORT

Planning Director Wilson is not present at this meeting. Rebecca Herrin distributes copies of the PowerPoint presentation on Cannabis Regulation and Enforcement Efforts by Ashley Worth and Griffin Perea from the Central Valley Water Board and Lt. Dewayne Little from the Department of Fish and Wildlife presented at the Cannabis Working Group meeting held on November 14, 2016. Herrin also distributes copies of email "If Proposition 64 passes, here's what Californians can do immediately under new law".

Commissioners ask questions of Dan Malugani, Code Enforcement Officer, about cannabis enforcement and how compliance with the cannabis ordinance now under development will impact the County. Malugani explains that he takes direction from the Sheriff on matters involving cannabis, but operates under the direction of the Building Official, the Environmental

Commissioners discuss various methods of enforcement that could be written into the ordinance to facilitate code enforcement. *[The Commission is not, at this time, involved in development of the cannabis ordinance. Discussion took place, but has no impact on the development of the cannabis ordinance.]*

There are no Planning Commissioners' announcements or reports.




Commissioner Olofson presents his list of priorities in updating the zoning code.
