Addendum to the previously adopted Mitigated Negative Declaration

Project Applicant: **Quincy Community Services District**
Reorganized as American Valley Community Services District, January 11, 2018

Project Location: The Project site is located on Spanish Creek Road, east of Highway 89, just north and east of the Gansner Field Airport, in the community of Quincy, Plumas County, California.

Project Description: The Quincy Community Services District (CSD) adopted a MND for the Quincy-East Quincy Wastewater Treatment Plant Improvement Project on February 9, 2017. On January 11, 2018, the Quincy CSD reorganized as the American Valley CSD, and the American Valley CSD adopted the MND and Mitigation Monitoring and Reporting Program on March 8, 2018. The MND addressed improvements to the Quincy Wastewater Treatment Plant and effluent disposal system, including two alternatives for the outfall pipeline, the potential installation of a solar photovoltaic power generation facility, and infrastructure improvements to adjacent pastures to maximize discharge potential. The Addendum addresses a third alternative alignment for the pipeline that would lead from the new treatment facility to the Spanish Creek outfall. The pipeline would be installed in existing access roads using open-cut trenching. The primary purpose of the project is to comply with Central Valley Regional Water Quality Control Board requirements for wastewater treatment and discharge.

This is to advise that the American Valley CSD Board of Directors approved the above-described project on **November 8, 2018**, and made the following determinations regarding the above-described project.

1. The project will not have a significant effect of the environment.
2. An Addendum to the previously adopted Mitigated Negative Declaration was prepared for this project pursuant to the provisions of CEQA.
3. Previously adopted mitigation measures were made a condition of the approval of the project.
4. A mitigation reporting or monitoring plan beyond that adopted in connection with the previously adopted Mitigated Negative Declaration was not adopted for this project.
5. A Statement of Overriding Considerations was not adopted for this project.
6. Findings were made pursuant to the provisions of CEQA.
