VII. PLANNING DIRECTOR'S REPORT

Planning Director Randy Wilson reports that handouts on 5G small cell regulations have been distributed to the Commissioners. These handouts are: 1. Federal Communications Commission Final Rules governing State and Local Regulation of the Placement, Construction, and Modification of Personal Wireless Service Facilities and 2. Email from CSAC with Comments and Action Needed: Submit Comments on FCC Proposal to Limit Local Control of 5G.

"As counties may be aware, the Federal Communications Commission (FCC) recently released a draft Declaratory Ruling and Third Report and Order, aimed at accelerating the deployment of

next-generation 5G wireless networks. The wireless telecommunications industry is now pursuing many of the same preemptions of local government authority that they unsuccessfully sought in California in 2017 via SB 649 (Hueso)-including capped rates for pole attachments and limitations on reasonable local government review."

Wilson adds that staff is reviewing these items to determine how to give direction to the Commission now that the public hearing has been set for the draft Telecommunications Ordinance.

The Board of Supervisors held a public hearing on Tuesday, October 16th and waived the first reading of the SRA Regulations (amendment to Plumas County Code) with adoption to come on October 23rd.

VIII. PUBLIC HEARING ITEM: PROPOSED ORDINANCE AMENDING TITLE 9 OF THE PLUMAS COUNTY CODE BY ADOPTING THE STATE'S MODEL WATER EFFICIENT LANDSCAPE ORDINANCE

The public hearing is opened. There is no staff presentation. Wilson recommends a continuance of the public hearing to time and date specific. The public hearing is continued until the meeting of November 1, 2018 at 10 a.m. with the public hearing to remain open.


