

**REGULAR MEETING OF THE BOARD OF SUPERVISORS  
COUNTY OF PLUMAS, STATE OF CALIFORNIA  
HELD IN QUINCY ON MARCH 06, 2007**

**1. ROLL CALL**

The meeting is called to order at 9:00 a.m. with Supervisors William Powers, Sharon Thrall, Robert Meacher and Chairman Ole Olsen present. Supervisor Rose Comstock is absent.

**2. INVOCATION AND FLAG SALUTE**

Pastor Tarleton from the First Baptist Church of Quincy offers the invocation and Supervisor Powers leads the flag salute.

**3. PUBLIC COMMENT OPPORTUNITY**

John McMorow, representing the Schomak Group is before the Board regarding their action taken on December 12, 2006 directing County Counsel to review Negative Declaration 606 for CEQA compliance in regards to the Feather River Inn project. Mr. McMorow is concerned because the review has not been done and the Feather River Inn project has been halted. Barbara Thompson, County Counsel responds.

Paul Davis, CHP Commander addresses the Board regarding the number of automobiles removed during the recent winter storm. The automobiles were removed to allow for snow removal.

**4. PLUMAS COUNTY DEPARTMENT HEADS COMMENT PERIOD**

Kelly Stane, Risk Manager addresses the Board with an update on CSAC Excess Insurance Authority estimated premiums for 2007-2008. Estimated increase for Plumas County is \$133,000 which represents a 25% increase in liability claims.

Charles Leonhardt gives a report and update on the Plumas County Health Insurance Advisory Committee.

**RESOLUTION RECOGNIZING TOM HUNTER – RCRC ESJPA**

Supervisor Meacher presents Tom Hunter with a Resolution recognizing him for his thirteen years as a valued member of the Rural Counties' Environmental Services Joint Powers Authority.

**6. BOARD OF SUPERVISORS**

**ONE STOP PERMIT CENTER-COMPLETION OF PROJECT**

Upon report and recommendation of Tom Hunter and following discussion by the Board, motion is made by Supervisor Powers, seconded by Supervisor Meacher and unanimously carried, with Supervisor Comstock absent, to approve Change Order No. 24; authorize recording Notice of Completion; and approve final payment of \$50,313.03 and release of retention for \$63,636.15 to BCM Construction Company, Inc. for completion of the One Stop Permit Center, Quincy, subject to installation issues being satisfied as outlined in a memorandum from William Kelley, CBO, dated March 06, 2007, with the exception of items No. 2 and 8, plan check errors. The Chair is authorized to sign the Notice of Completion once issues have been satisfied. A copy of the memorandum is on file with the Clerk of the Board and Planning & Building Services.

**HEALTH & HUMAN SERVICES CENTER**

Motion is made by Supervisor Meacher, seconded by Supervisor Thrall and unanimously carried, with Supervisor Comstock absent, to approve Change Order No. 10, 11, 12 to BCM Construction Company, Inc. for \$116,550.92 for the Health & Human Services Center as recommended.

### **PRIORITIZATION OF 2007 HR 2389 TITLE III FUNDING**

Following brief discussion, this matter is continued to March 13, 2007 to discuss prioritization of 2007 HR 2389-Title III funding and to set a date for special meeting of the Board to review applications.

### **COUNTYWIDE FIRE AGENCY – FORMATION OF STUDY GROUP**

Supervisor Meacher brings this matter before the Board seeking approval to form a study group for development of a countywide fire agency. Supervisor Meacher explains the role of the study group will be to review emergency medical response issues, mutual aid issues, develop a job description for the Director of Office of Emergency Services and County Fire Marshal, work with the Special Districts to develop a process for billing back services, etc. Supervisor Meacher assures the Board and members of the public this is not an effort to consolidate or eliminate special districts. Jim Pena, Plumas National Forest Supervisor requests that a member of the Forest Service sit on the study group.

Motion is made by Supervisor Meacher, seconded by Supervisor Powers and unanimously carried, with Supervisor Comstock absent, authorizing the formation of a study group for development of a countywide fire agency.
