

**REGULAR MEETING OF THE BOARD OF SUPERVISORS
COUNTY OF PLUMAS, STATE OF CALIFORNIA
HELD IN QUINCY ON FEBRUARY 07, 2006**

1. ROLL CALL

The meeting is called to order at 9:00 a.m. with Supervisors Rose Comstock, William Powers, William Dennison, Ole Olsen and Chair, Robert Meacher present.

2. INVOCATION AND FLAG SALUTE

Pastor Tarleton from the First Baptist Church of Quincy offers the invocation and Supervisor Dennison leads the flag salute.

John Schramel, a member of the public addresses the Board regarding their recent adoption of an Ordinance increasing the speed limit on Main Street in Greenville to allow for radar enforcement. Mr. Schramel and various residents are concerned the problem is worse and request a further study.

11. COUNTY ADMINISTRATIVE OFFICE

FY 2005/2006 SB90 FUNDS FOR ANIMAL CONTROL, RESCIND ACTION TAKEN

Upon report and recommendation of Jack Ingstad, CAO, motion is made by Supervisor Dennison, seconded by Supervisor Powers and unanimously carried to rescind action taken on January 10, 2006 approving a supplemental budget for \$16,000 of SB90 funds for Animal Control for FY 2005/2006.

12. BOARD OF SUPERVISORS

RISK MANAGER/OCCUPATIONAL SAFETY & HEALTH SPECIALIST CONTRACT

Following discussion, motion is made by Supervisor Comstock, seconded by Supervisor Powers and unanimously carried to approve a contract with Kelly Stane, effective February 15, 2006 as Risk Manager/Occupational Safety & Health Specialist, and authorize the Chair to sign, as amended. It is agreed that the position of Risk Manager/Occupational Safety & Health Specialist will report directly to the County Administrative Officer.

APPOINTMENT OF PLUMAS COUNTY AUDITOR/CONTROLLER

Motion is made by Supervisor Dennison, seconded by Supervisor Powers and carried with Supervisor Comstock opposing to appoint Shawn Montgomery as Plumas County Auditor/Controller, effective February 14, 2006 and upon approval of an agreement.

TAX SHARING POLICY FOR SPECIAL DISTRICTS ANNEXATIONS

This matter is before the Board for discussion and possible action to establish guidelines and appoint a negotiating committee for negotiating with special districts regarding sharing of the tax increment resulting from annexation. Following discussion motion is made by Supervisor Dennison and seconded by Supervisor Powers adopting a Tax Exchange Policy for Annexations, as amended; and appoint Supervisors Dennison and Powers, the County Administrative Officer, and County Counsel to negotiate the potential exchange of property tax with special districts in regard to pending LAFCo annexation files. This committee shall report back to the Board of Supervisors with a recommendation following such negotiations. AYES: Supervisors Dennison, Comstock, Powers and Meacher. NOES: Supervisor Olsen. ABSENT: None. Carried and so

ordered. Amendments will be made to the Policy and placed on the consent agenda for approval on February 14, 2006.

Supervisor Olsen is opposed because he believes the County should share, without negotiating, a portion of the tax increment with special districts. Supervisor Olsen believes there are many areas within Plumas County that do not receive adequate county services as taxpayers.
