**6. BOARD OF SUPERVISORS**  
**DEVELOPMENT IMPACT FEES**

Further discussion regarding establishing Development Impact Fees in Plumas County. Impact Fees are charges imposed on new development, residential and otherwise, for the purpose of generating additional revenues to offset local government's capital improvement expenditures. On August 15, 2006, the Board adopted Resolution No. 06-7302, by a three/two vote with Supervisor Dennison absent and Supervisor Olsen opposed, establishing Development Impact Fees and adopting the Comprehensive Impact Fee (Nexus) Study for the County of Plumas, effective January 01, 2007.

Before the Board adopts a County Ordinance, as required, Chairman Meacher has requested this matter be revisited as a workshop to explore other ways impact fees are imposed. Chairman Meacher refers to information received from the Rural Council of Rural Counties regarding this matter. Supervisor Meacher refers to information from Tuolumne County and their process used to establish a growth impact fee that was labeled, County Services Impact Fee. The material provides the Board with information not provided by Pacific Municipal Consultants (PMC). Supervisor Meacher believes the information from Tuolumne County could help guide the Board in their decision how impact fees are imposed.

There is further discussion by the Board regarding how impact fees may be assessed. They proceeded to discuss how to define affordable housing in Plumas County. The Board agrees the impact fee should apply to residential development, meaning single-family residences, etc., and agree to establish a "fee waiver" policy for 1500 square feet or less for single-family residences outside of a development.

Jack Ingstad, CAO recommends the Board give direction of what they are trying to accomplish and let staff provide the tools needed to move forward.

Jonathan Schnal, Director of planning & Building recommends imposing monetary fee exactions on development projects to mitigate the impacts of such projects on the public facilities and services.

Following discussion by the Board, motion is made by Supervisor Comstock, seconded by Supervisor Powers and unanimously carried, with Supervisor Dennison absent, directing staff to return with an array of possibilities to include an Ordinance requiring that all development projects countywide have a 10% zoning for affordable housing; a model for an exaction fee; identify a fee waiver program and components and the requirements for a budget and trust fund.

This matter is continued to December 05, 2006.
