3. **Relocation of Plumas Transit bus stop at Plumas Pines Shopping Center** – Jim Graham reports that Public Works has removed the bus stop within the Plumas Pines Shopping Center pursuant to the demand to vacate the property by the management firm for the shopping center.

Jim Graham explains that Public Works is working expeditiously to identify replacement stops in proximity to the signalized intersection.


Several Alive program riders express difficulty utilizing the new stops due to distance and lack of shelter. Gary McFarland, suggest using the transit system deviated response to pick up Alive members at an alternate location. Other modifications are made in order to accommodate passengers getting off at the Foley stop.

Jim Graham will provide regular updates regarding progress towards the development of new bus stops.

Reno run. The group decides to reinvigorate efforts to promote this service to the transit dependent population before promoting the service to the general public.
