HeartSafe Community

- AED Registration Requirement.
 - Pulse Point App acts as a registry which meets state requirements. At this time Chester and Indian Valley have inputted AED into Pulse Point
 - Eastern Plumas should register their AED with Pulse Point
 - The Pulse Point app is a public application
- Update from Central Plumas by Sam Blesse:
 - **Sam will follow-up with Carson regarding how many AED will be needed to place in every SO patrol vehicle:** goal is for every SO deputy on patrol to have an AED in patrol vehicle
 - Boat patrol has AEDs during the summer and AED are in substation- some have 2 or 3
 - Eastern Plumas (Elaine) may have extra AEDs for SO
 - CPR classes started in Taylorsville/ Greenville
 - Taylorsville Tavern and Plumas Bank in Greenville has AED
 - Letter of Intent will be submitted for Indian Valley
 - **Sam will provide handout to Eastern Plumas (Corina/Elaine) on AED liability for businesses**
- Letter of Intent received from EPHC Ambulance.
 - Once application is received a sub-committee will review the application and make recommendation to Public Health for approval
- Update from Lake Almanor by Chris Dean and Brian Layne
 - Nothing new except it is a work in progress since Karen retired
 - Chris Dean or Matt Turner will be contact for HeartSafe

Update from Nor-Cal EMS

- Update provided by Dona Stone
- Three new employees join Nor Cal: EMS Specialist is Mark Thomas; Air Medical is Nick and Clinical Coordinator is Jenny McGuire
- All three positions are part time and will be defining each person's role over the next couple weeks
- Nor Cal is working on policies and looking into various grants

Health Care Coalition (Tri-HCC):

- The Tri-HCC has been very busy due to COVID-19 response. Many of the deadlines for required deliverables have been extended including the Pediatric Surge Plan.

- The Tri-HCC held meeting on May 6, 2020, with the next meeting scheduled for August 5, 2020 (it was later moved to August 12, 2020).
- The Tri-HCC has been working with hospitals during COVID-19 and still moving forward with the Pediatric Surge Plan.

PCSO- Communication Update:

- Mike Grant provides update: Paging issue regarding fire has been resolved
- Dispatch radio console will be installed in couple weeks at station
- E-dispatch: departments can buy into an application for cell phones: it is redundant communication. It will tone cell phones to alert. Departments can sign up for the app for \$40-80 a month depending on size of the department and each department need to maintain their own data base.

Appointment of EMCC Officers:

- The EMCC Chair and Vice- Chair need to be filled: Each are a two year term and not more than two terms.
- Only voting members can be an officer- Joe Waterman not interested in another term.
- Tina Venable nominates Sam Blesse for Chair and Darren Beatty seconds the motion with all in favor.
- Sam Blesse nominates Corina Corbridge for Vic-Chair; however, she declines.
- Sam Blesse nominates Mike Grant as Vice-Chair and Tina Venable seconds the motion with all in favor.
- The new officers will take effect next meeting.

Agency Reports:

- Sam @Careflight: Ground has new type 2 ambulance sprinter. Applied for grant like EPHC. PPE is good the challenge is keeping crews motivated to wear them. PDH doing on-line sign-ups for CPR
- Corina @EPHC ambulance: 6 AED placed in Eastern Plumas and 4 need to still be placed; working on campaign community for HeartSafe. CPR classes will be available soon on-line and working on trying to incorporate Sierra County
- Dee Dee@ EPHC: COVID-19 guidelines keep changing; New CEO Doug McCoy; Held two COVID-19 mass testing events with another on July 8
- Elaine@ Eastern Plumas Rural Fire District: New type 1 and type 3 engines will be operable in a month and half.
- Sherrie Thrall@ BOS: starting budget process
- Joe@ Fire Association: Last meeting canceled- have e-mail type of meeting
- Becky@ S.O.: ambulance dispatch making sure ILI questions being asked, Issue regarding 395 corridor for EMS is it EPHC ambulance or REMSA?
- Chris @SEMSA: 4th ambulance in Lassen County, SEMSA would like to be placed back on rotation for air medical, **meeting to be arranged with EMCC, SO and SEMSA air**

- Darren @PDH: COVID-19 rapid testing is on-line with another device in July, anti-body being conducted in-house with first positive employee, great response by team and continue to monitor, Day care will be operational by fall and the SNF operational in next 3 years
- Linda @ Seneca: On June 25th amateur radio test with the Lake Almanor network. COVID-19 mass testing on July 7th at Seneca, will have mass testing once a month, nt receiving timely information on local fires
- Lt. Egide @ CHP: all good; officer responded to 395 emergency and performed CPR, revived person
- Matt @ Careflight (air): Status quo, keep staff healthy
- Dr. Satterfield: kudos to all hospitals/ EMS regarding COVID-19
