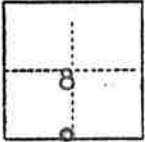

FOUND: Live 42" J. Pine w/ opened face and scribing "BT" visible. Tree has approx. 30 ft. of top missing and lightning scar. No evidence of NE bearing tree.

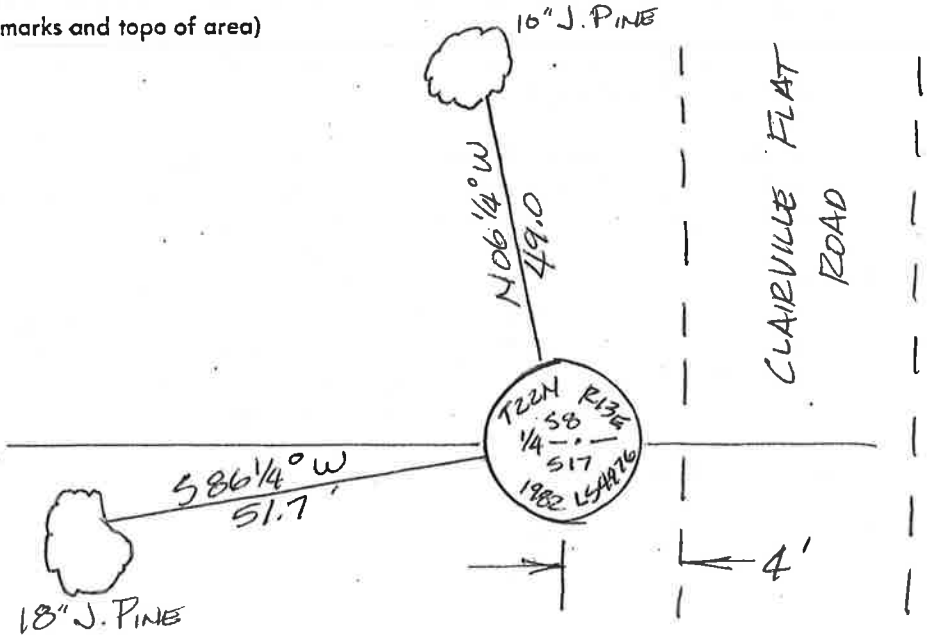
