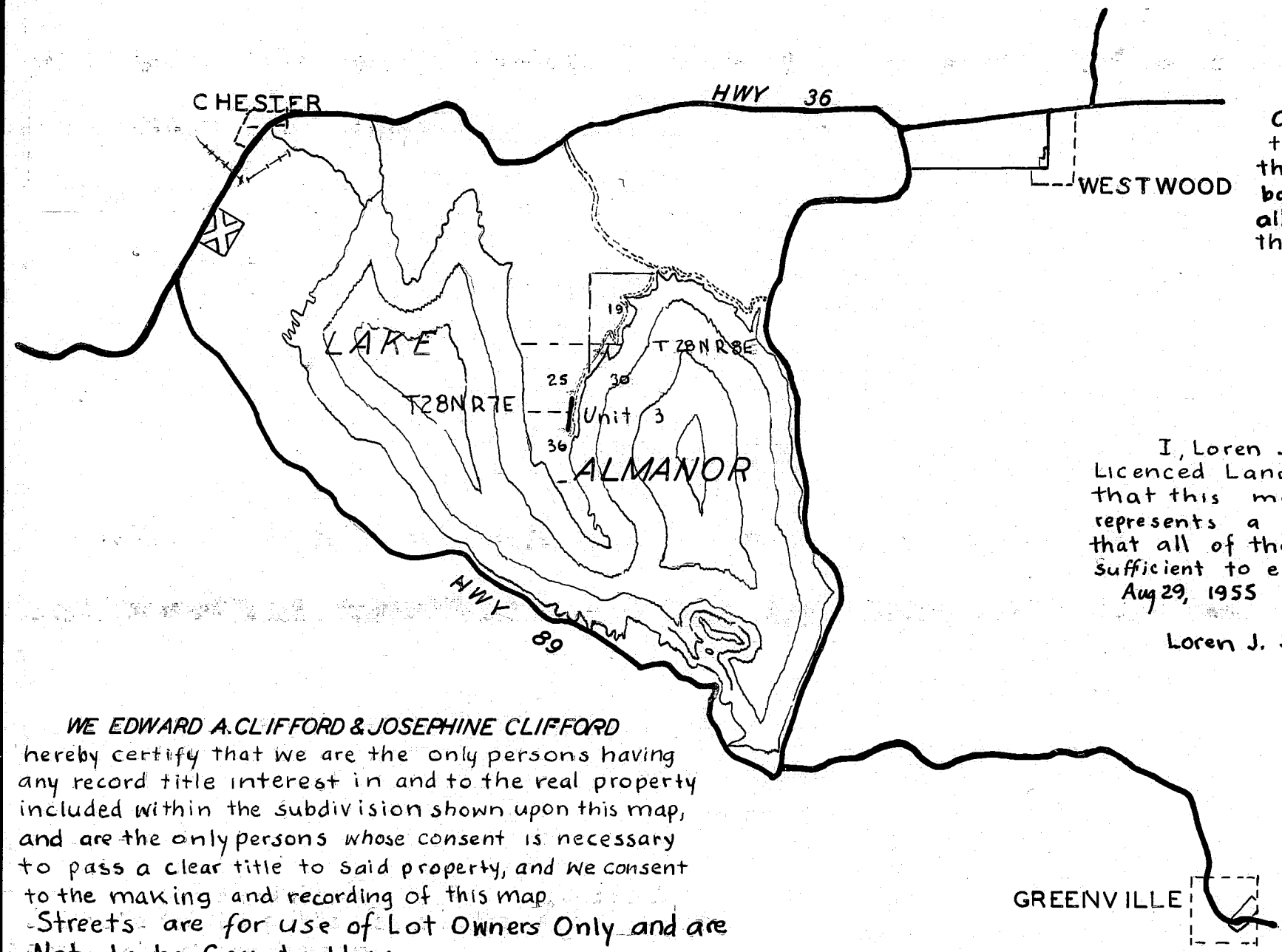


VICINITY MAP LAKE ALMANOR
