


(a) Rights of way and easements for water, gas, sewer and drainage pipes and for poles and overhead and underground wires for electric and telephone service, together with any and all appurtenances appertaining thereto on, over and under those strips of land lying between the rear and/or side lines of lots, and the lines designated "PUBLIC UTILITY EASEMENT LINE".

(b) Easement for light and air over those strips of land lying between the front and/or sidelines of lots and those lines designated "SETBACK LINE" said strips to be kept open and free from buildings.
