OWNER'S CERTIFICATE

THE UNDERSIGNED HEREBY CERTIFY THAT THEY ARE THE OWNERS OF OR HAVE SOME RIGHT, TITLE OR INTEREST IN AND TO, THE REAL PROPERTY INCLUDED WITHIN THIS SUBDIVISION AND ARE THE ONLY PERSONS WHOSE CONSENT IS NECESSARY TO PASS CLEAR TITLE TO THIS LAND; AND THEY HEREBY CONSENT TO THE PREPARATION AND RECORDING OF THIS MAP; AND THEY DO HEREBY DEDICATE TO THE PUBLIC FOR THE HERINAFTER DESCRIBED PURPOSES THE FOLLOWING EASEMENTS, ALL IN ACCORDANCE WITH THE IMPROVEMENT PLANS APPROVED BY THE PLUMAS COUNTY DIRECTOR OF PUBLIC WORKS:

1. INGRESS, EGRESS AND SUPPORT:
 AN EASEMENT FOR INGRESS, EGRESS AND SUPPORT THROUGH LOT "A" FOR THE USE BY ALL PUBLIC UTILITIES, LAW ENFORCEMENT, FIRE PROTECTION, WELFARE AND OTHER RELATED PUBLIC OR COUNTY AGENCIES, THEIR VEHICLE AND PERSONNEL FOR THE SOLE PURPOSE OF PERFORMING OFFICIAL BUSINESS, AND THE 30' EASEMENT ON LOT "B" FOR STREETS AND UTILITIES.
2. UTILITY EASEMENTS:
 EASEMENTS FOR INSTALLATION, MAINTENANCE AND REPAIR OF ALL UTILITIES CONSTRUCTED OVER, ON, ACROSS AND UNDER LOTS "A" & "B" WITH THE RIGHT TO TRIM AND REMOVE, AS OFTEN AS NECESSARY, TREES, LIMBS AND BRUSH FOR THE SOLE PURPOSE OF INSTALLING, MAINTAINING AND/OR REPAIRING SAID UTILITIES.
3. OPEN SPACE EASEMENTS OVER, ON, ACROSS, AND UNDER LAND DESIGNATED ON THIS MAP, "OSE". THIS SHALL BE FOR THE PROTECTION OF LIGHT, SPACE, NATURAL ENVIRONMENT AND HABITAT, AND COMPATIBLE RECREATIONAL USES. WRITTEN PERMISSION MUST BE OBTAINED FROM THE COUNTY OF PLUMAS TO CUT TREES, EXCAVATE, BENCH, REGRADE AND MODIFY DRAINAGE, OR ERECT STRUCTURES THEREON.

AFTER INITIAL INSTALLATION AND CONSTRUCTION, AS SET FORTH ON THE IMPROVEMENT PLANS AS APPROVED BY THE PLUMAS COUNTY DIRECTOR OF PUBLIC WORKS, FUTURE MODIFICATIONS WITHIN THE DEVELOPMENT WILL BE SUBJECT TO THE DECLARATION OF COVENANTS, CONDITIONS AND RESTRICTIONS.

THE FOLLOWING PROVISIONS ARE PART OF THE "DECLARATION OF COVENANTS, CONDITIONS AND RESTRICTIONS" WHICH ARE A PART OF EACH GRANT DEED, RECORDED SIMULTANEOUSLY WITH THE FILING OF THIS MAP WITH THE PLUMAS COUNTY RECORDER AND SHALL NOT BE SUBJECT TO AMENDMENT, MODIFICATION OR CHANGE WITHOUT THE PRIOR WRITTEN APPROVAL OF THE COUNTY OF PLUMAS:

1. INGRESS, EGRESS AND SUPPORT:
 (A) EASEMENT FOR INGRESS, EGRESS AND SUPPORT THROUGH THE COMMON AREA AS DEFINED IN SAID DECLARATION SHALL BE GRANTED TO EACH LOT OWNER WITHIN THIS SUBDIVISION AND MADE APPURTENANT TO SAID LOTS.
 (B) AN EASEMENT FOR INGRESS, EGRESS AND SUPPORT THROUGH SAID COMMON AREA SHALL BE GRANTED FOR USE BY ALL PUBLIC UTILITIES, LAW ENFORCEMENT, FIRE PROTECTION, WELFARE AND OTHER RELATED PUBLIC OR COUNTY AGENCIES, THEIR VEHICLES AND PERSONNEL.
2. COMMON AREA LAND USE:
 THE COUNTY OF PLUMAS SHALL HAVE THE RIGHT TO REVIEW AND APPROVE OR DISAPPROVE ANY CHANGES OF LAND USE IN SAID COMMON AREA.
3. UTILITY EASEMENTS:
 PUBLIC UTILITY EASEMENTS ARE HEREBY GRANTED OVER, ON, ACROSS AND UNDER SAID COMMON AREA FOR THE INSTALLATION AND MAINTENANCE OF FACILITIES IN ACCORDANCE WITH SAID "DECLARATION," RECORDED SIMULTANEOUSLY WITH THE FILING OF THIS MAP WITH THE PLUMAS COUNTY RECORDER.
4. OPEN SPACE EASEMENTS OVER, ON, ACROSS, AND UNDER LAND DESIGNATED ON THIS MAP "OSE". THESE SHALL BE FOR THE PROTECTION OF LIGHT, SPACE, NATURAL ENVIRONMENT AND HABITAT, AND COMPATIBLE RECREATIONAL USES. WRITTEN PERMISSION MUST BE OBTAINED FROM THE COUNTY OF PLUMAS TO CUT TREES, EXCAVATE, BENCH, REGRADE, MODIFY DRAINAGE OR ERECT STRUCTURES THEREON.
