





1. ROADS SHOWN HEREON AS "BRAE GATE, WENDRILL, EVOLUTION, BALSAM, PANORAMIC AND BLACK OAK ROADS" ARE PRIVATE ROADS SUBJECT TO THE RIGHTS OF WAY AND EASEMENTS NOTED HEREON AND ARE NOT SUBJECT TO IMPROVEMENTS OR MAINTENANCE BY PLUMAS COUNTY. IT WILL BE REQUIRED THAT SUCH ROADS BE IMPROVED TO COUNTY STANDARDS AT NO COST TO THE COUNTY BEFORE SUCH ROADS MAY BE ACCEPTED INTO THE COUNTY ROAD SYSTEM.
2. A SOIL REPORT ENTITLED "PRELIMINARY SOILS AND GEOLOGIC INVESTIGATION FOR THE RAMELLI RANCH PROPERTY, PLUMAS COUNTY CALIFORNIA" PREPARED IN JANUARY, 1979 BY TODD NELSON, C.E.G. AND ROBERT D. HOWELL, C.E. OF J.H. KLEINFELDER AND ASSOCIATES, RENO NEVADA, IS ON FILE IN THE PLUMAS COUNTY ENGINEER'S OFFICE.
3. ALL BEARINGS ARE GRID, BASED ON THE CALIFORNIA COORDINATE SYSTEM, ZONE 1. THE BASIS OF BEARING IS THE LINE BETWEEN THE S.E. AND S.W. CORNERS OF SECTION 22; T. 23 N., R. 14 E., PER 3 R.S. 63 OF PLUMAS COUNTY RECORDS, SAID LINE HAVING A RECORD BEARING OF S 88° 44' 05" W. ALL DISTANCES ARE GROUND ROTATION FROM GRID TO GEODETIC BEARINGS = 1° 03' 12" COUNTERCLOCKWISE.
4. LEACH EXCLUSION AREAS ARE TO INCLUDE ALL SLOPES OVER 30%, AREAS WITHIN 50' FROM SEASONAL DRAINAGES AND 100' FROM SPRINGS, WELLS AND YEAR-ROUND STREAMS, AND WITHIN A DISTANCE OF 4 TIMES A CUT BANK HEIGHT FROM THE TOP OF CUT BANK, IN CONJUNCTION WITH THE REQUIREMENTS OF PLUMAS COUNTY ORDINANCE 76-162.
5. ARCHAEOLOGICAL SITES ARE DESIGNATED HEREON AS A DOTTED LINE BOUNDARY AND LABELED AS CA-PLU-326, ETC. THESE SITES ARE BUILDING AND EXCAVATION EXCLUSION AREAS. GROUND DISTURBANCE WITHIN THESE AREAS MUST BE APPROVED IN WRITING BY A PROFESSIONAL ARCHAEOLOGIST PRIOR TO ANY EXCAVATION. ADDITIONAL BUILDING AND LEACH EXCLUSION AREAS ARE DESIGNATED HEREON.
