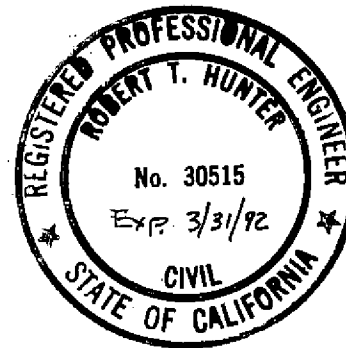


ENGINEER'S STATEMENT

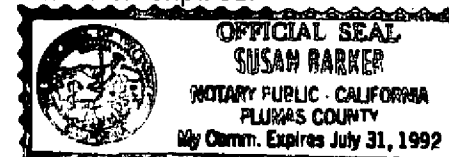
