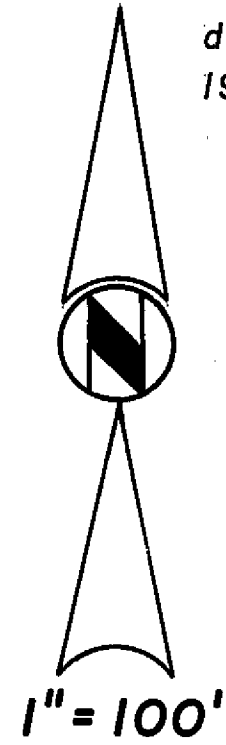


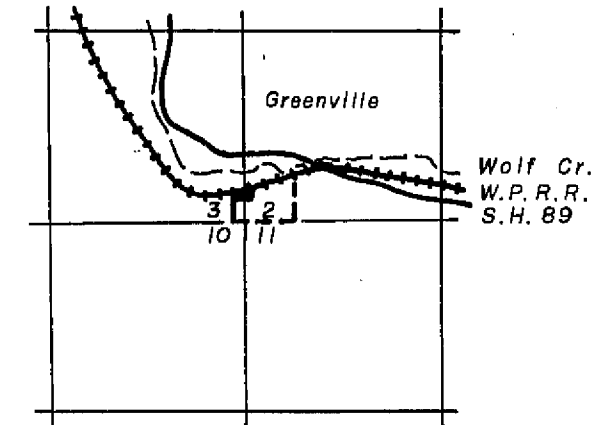
COUNTY ENGINEER'S CERTIFICATE

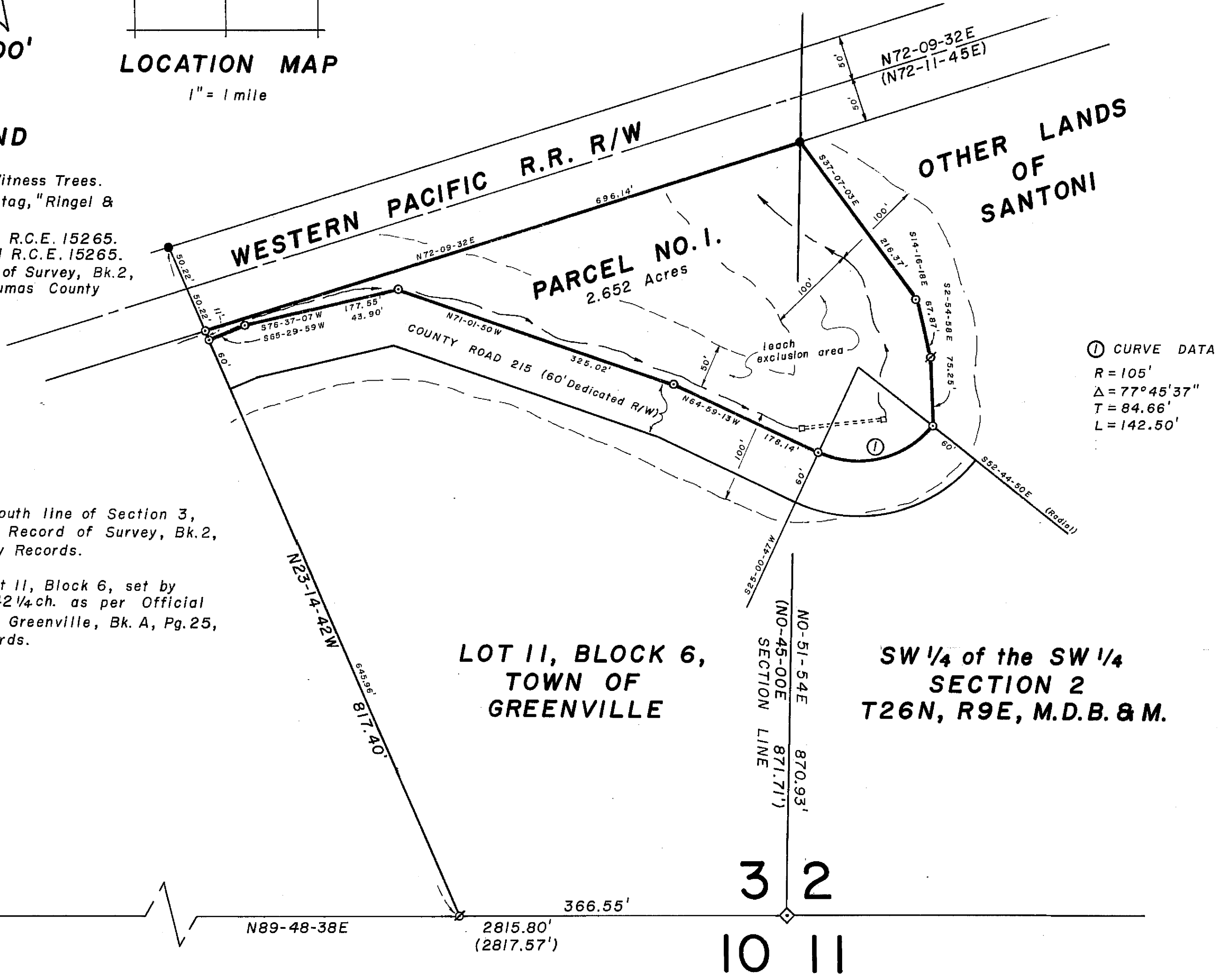
