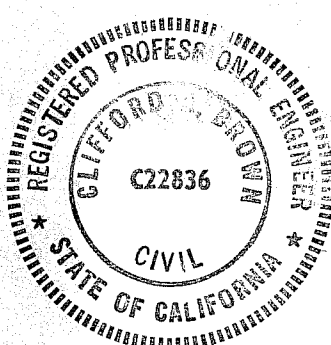
ENGINEER'S (SURVEYOR'S) CERTIFICATE

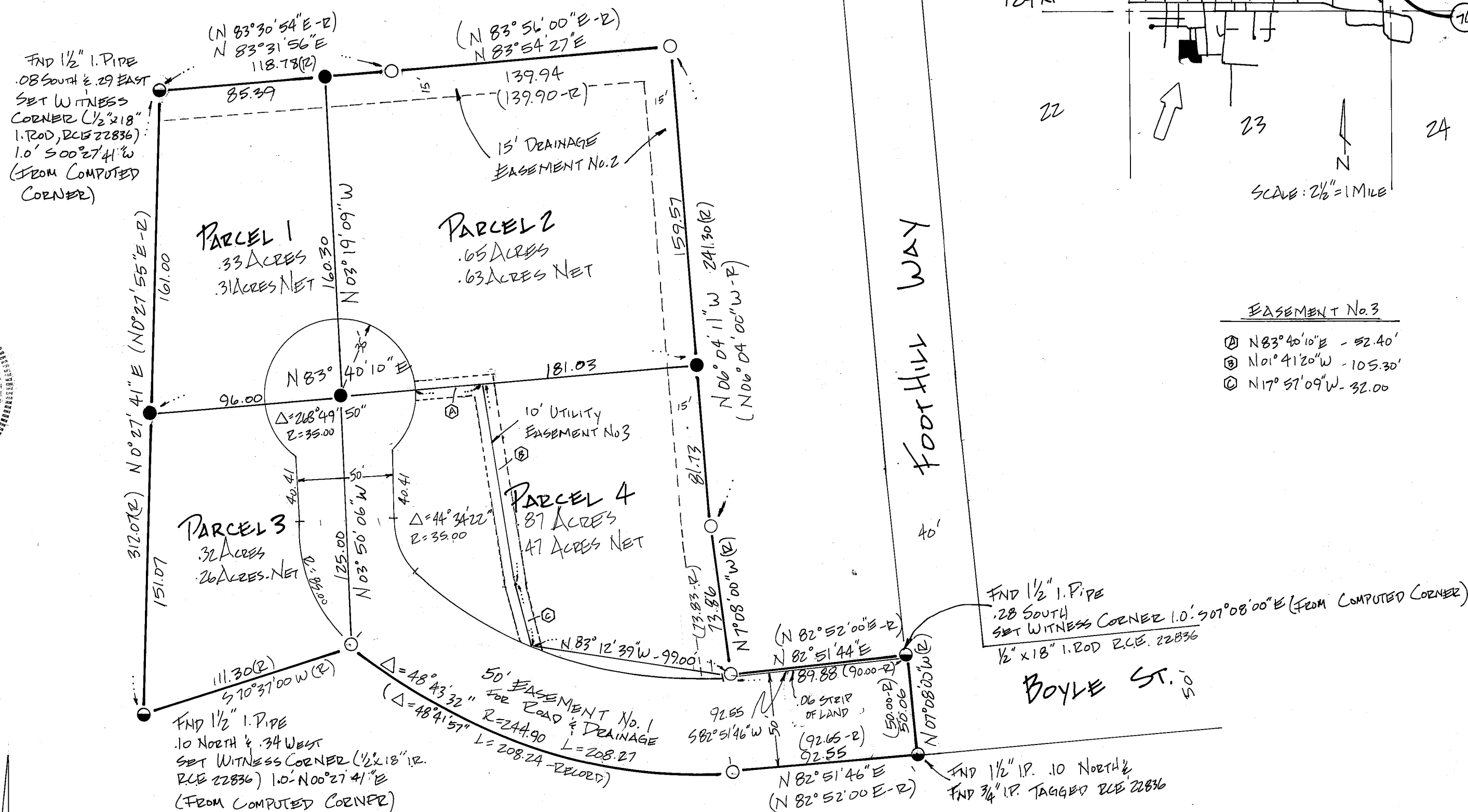
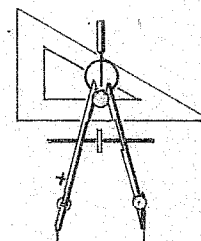
