

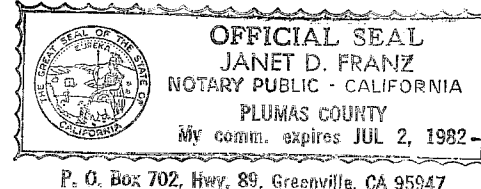
OWNER'S CERTIFICATE

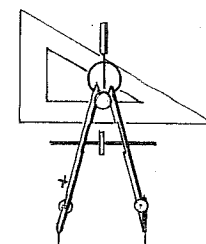

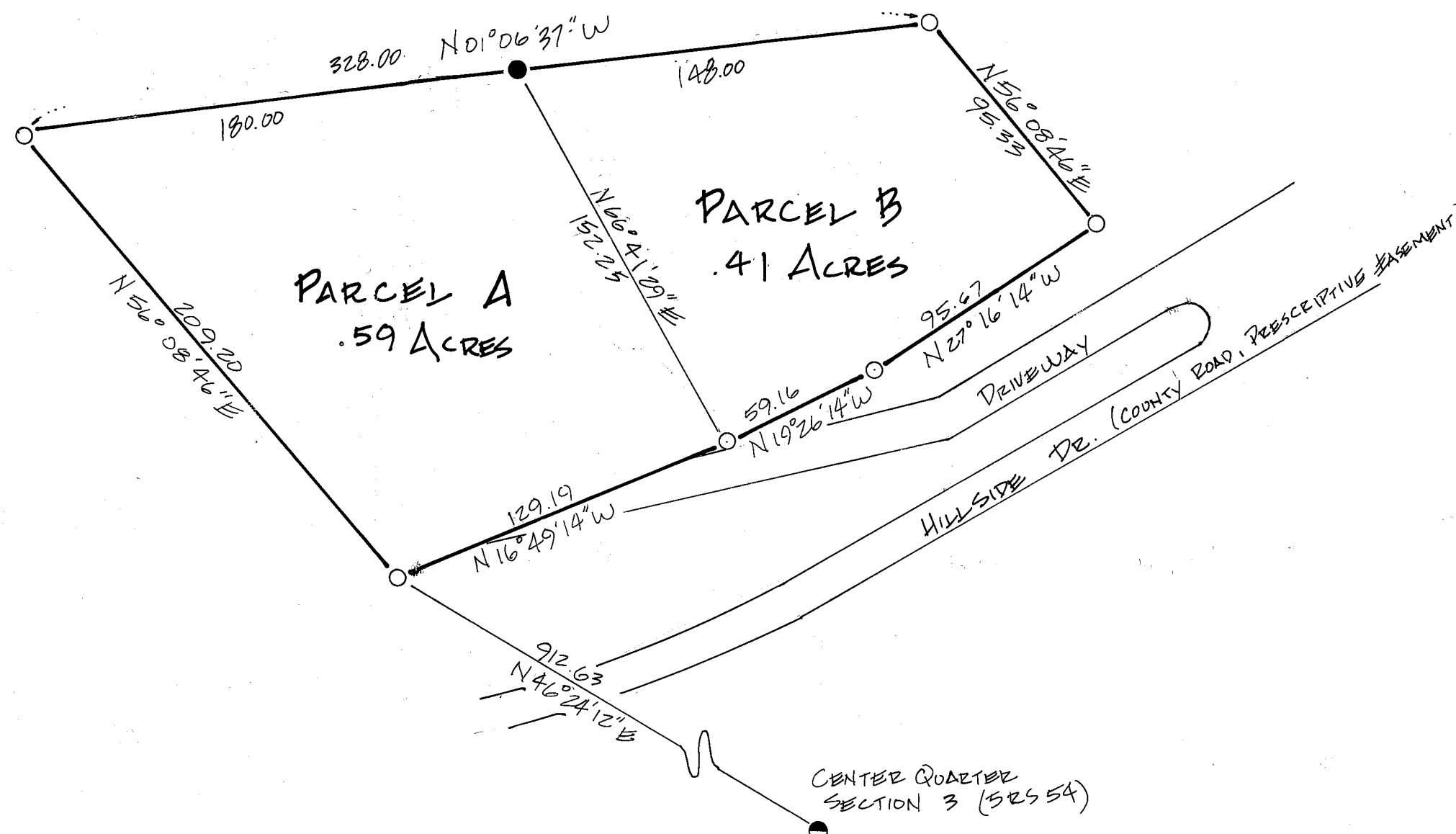

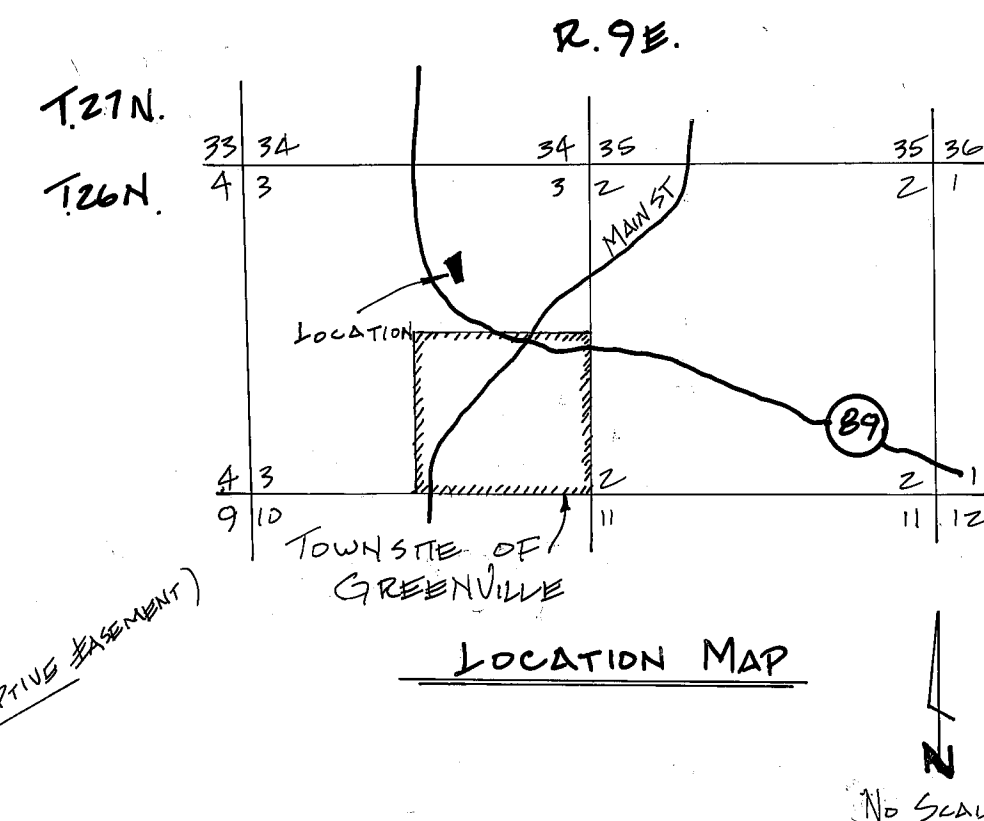
