

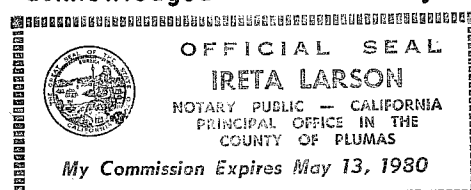
## OWNER'S CERTIFICATE

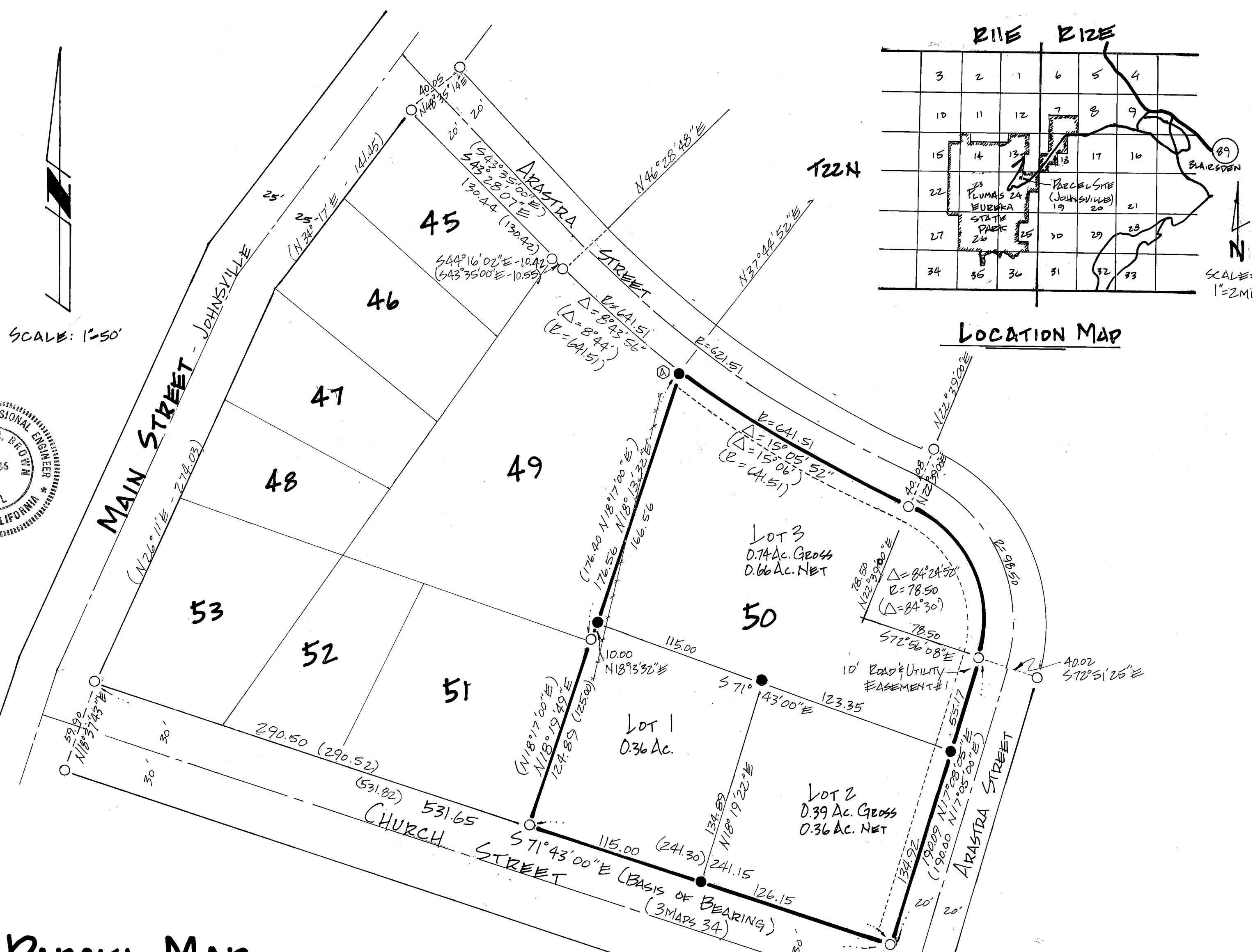
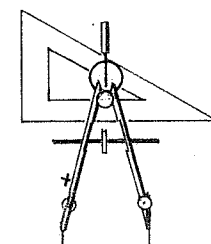
