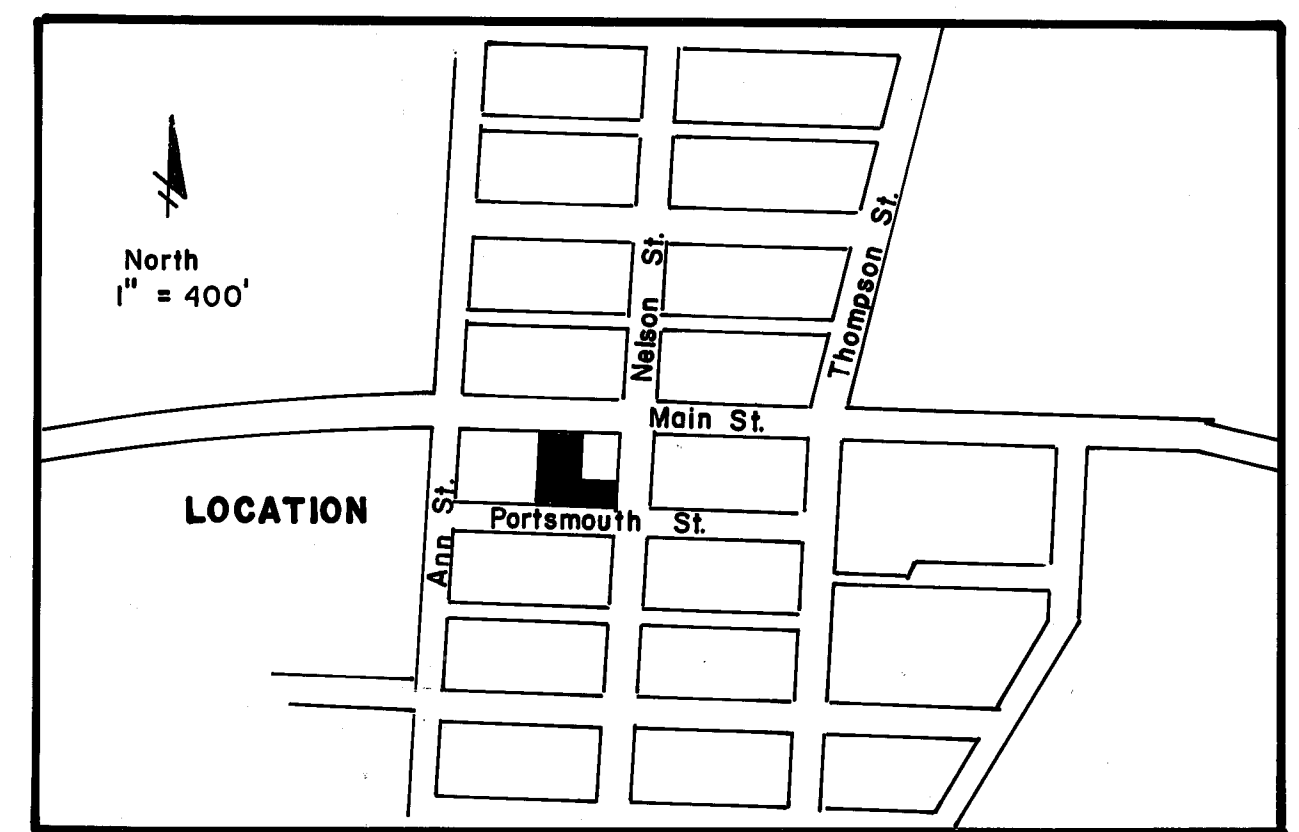

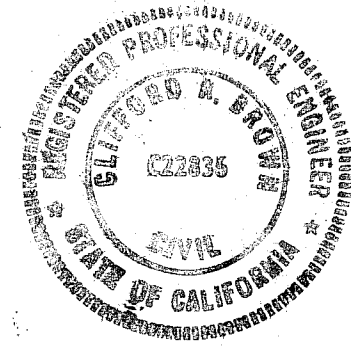


**TOWN OF TAYLORSVILLE**

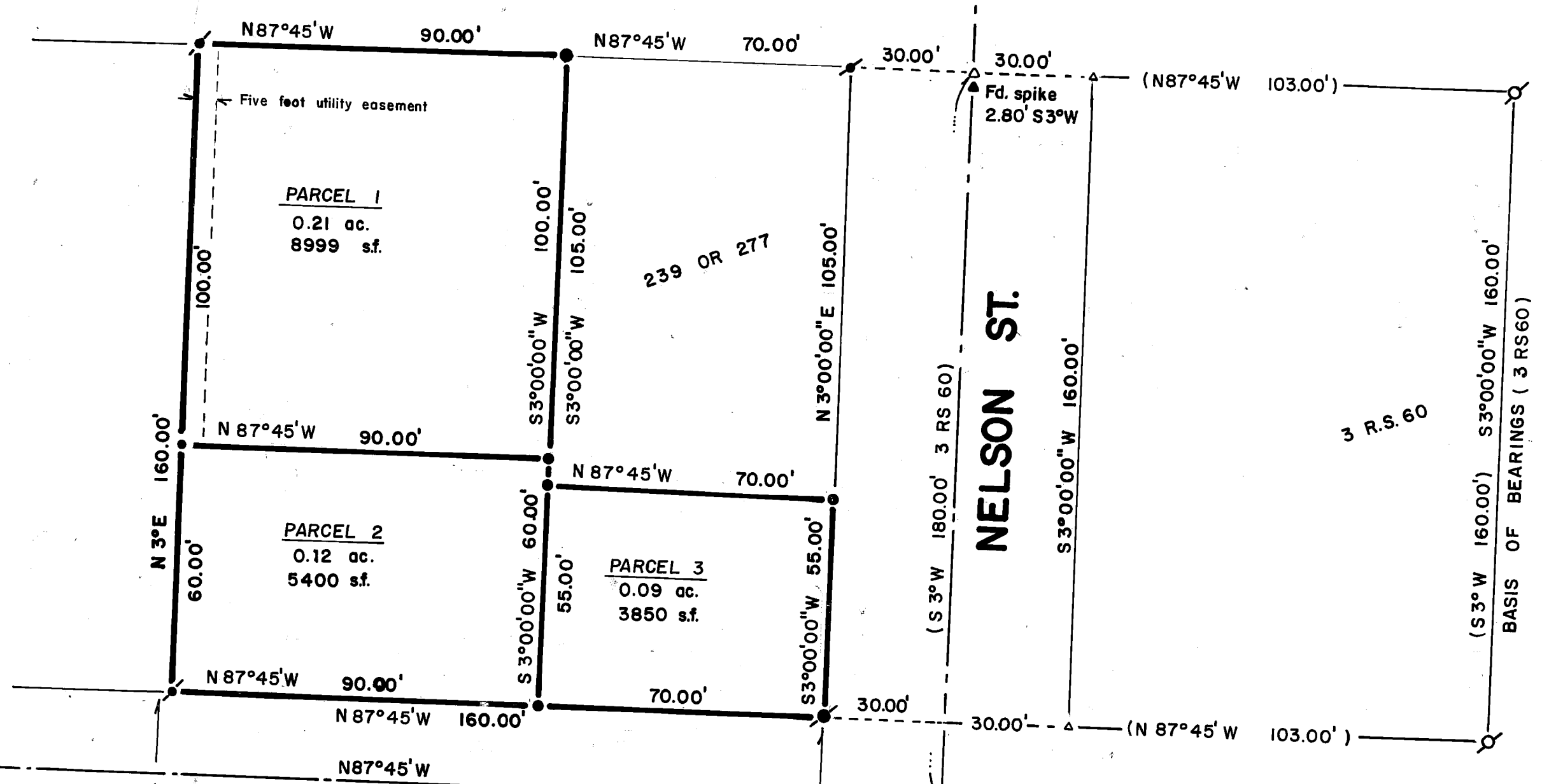
