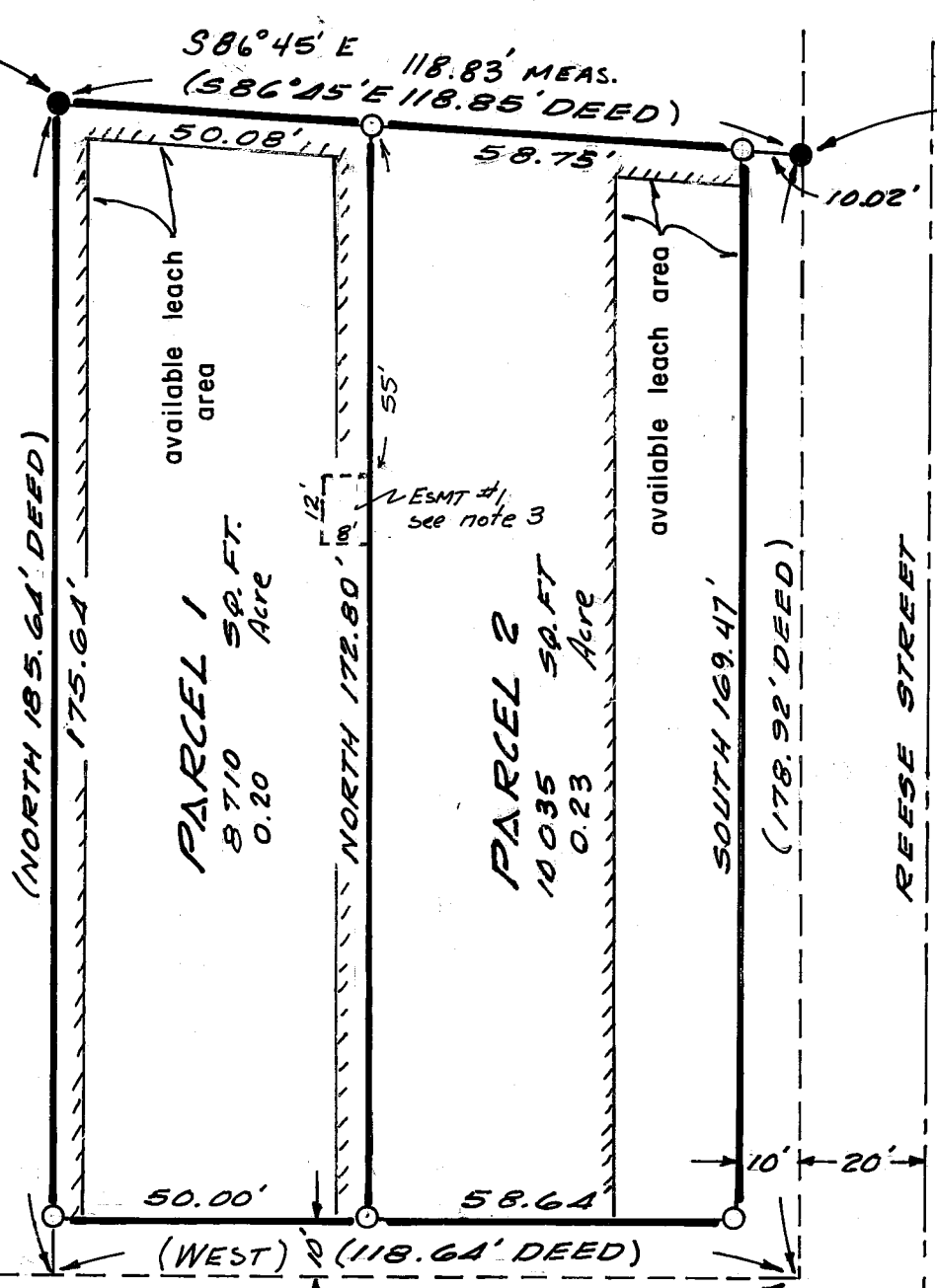
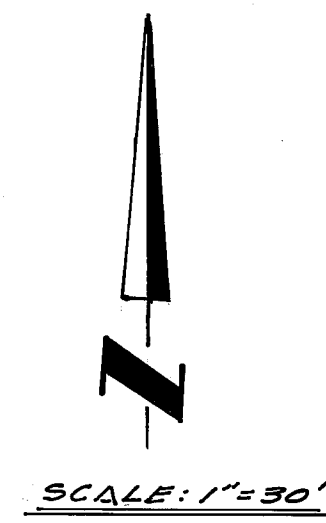


LOCATION MAP

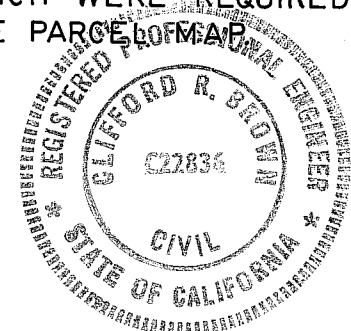
