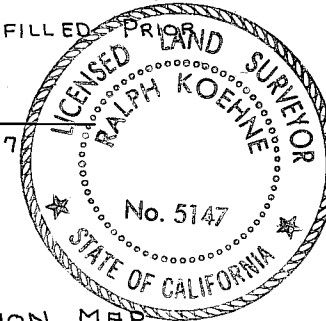


SURVEYOR'S CERTIFICATE

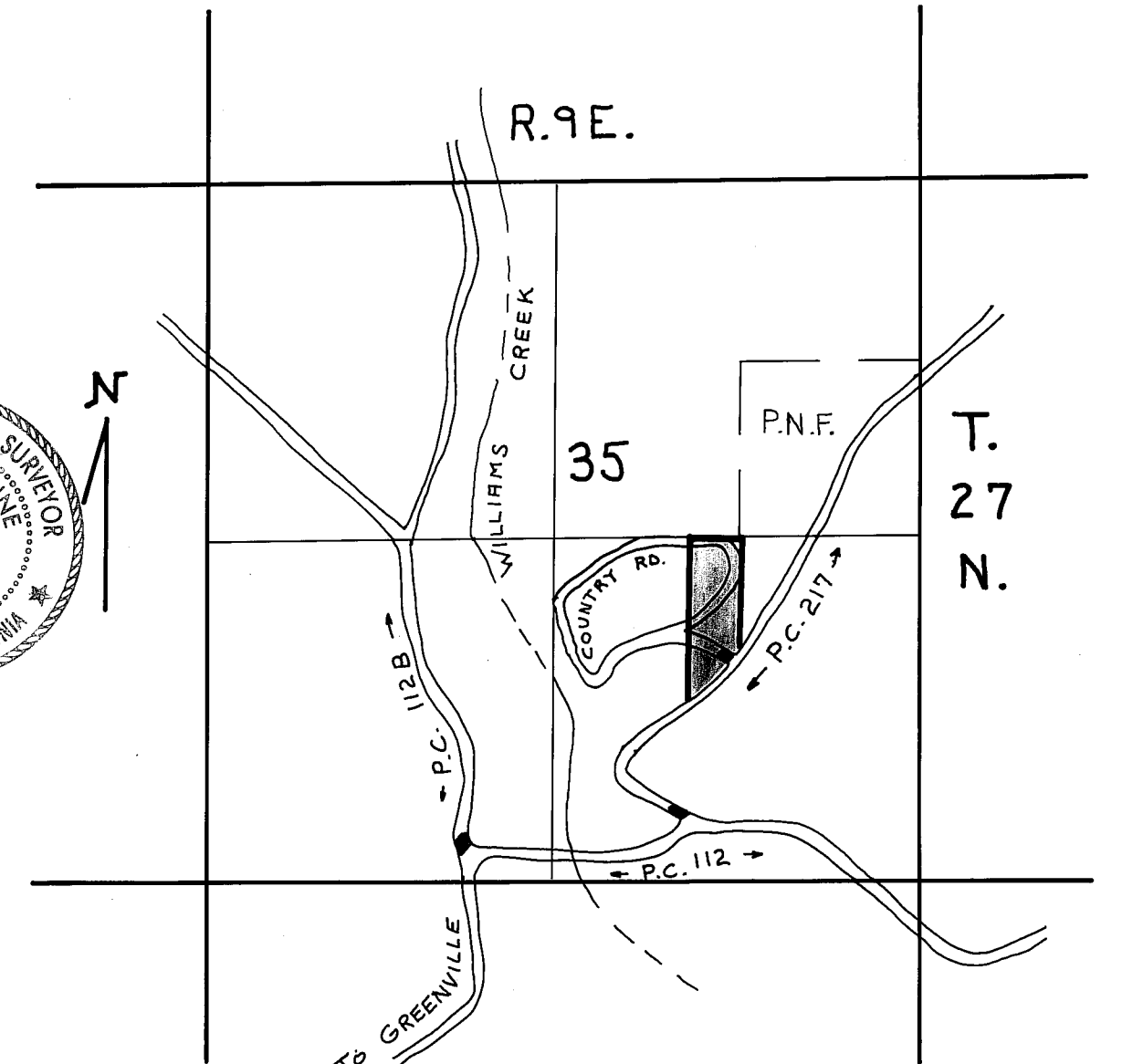

LEACH EXCLUSIONS ARE ALL AREAS WITHIN 50' OF PROPERTY LINES, WITHIN EASEMENTS, WITHIN 50' OF WATERCOURSES, WITHIN 100' OF EXISTING WELLS, PROPOSED WELL LOCATIONS AND EXISTING SPRINGS, WITHIN A DISTANCE OF FOUR TIMES THE HEIGHT OF ANY CUTBANK AND ALL AREAS WITHIN SLOPES IN EXCESS OF 30%.

ROADS SHOWN HEREON ARE PRIVATE EASEMENTS. SAID ROADS ARE NOT SUBJECT TO PLUMAS COUNTY IMPROVEMENTS OR MAINTENANCE. DECLARATION OF RESTRICTIONS AND ROAD MAINTENANCE AGREEMENTS IS ON FILE WITH THE COUNTY RECORDER IN BOOK 389 OF OFFICIAL RECORDS AT PAGE 481. SUCH EASEMENTS WILL NOT BECOME EFFECTIVE UNLESS AND UNTIL RESERVATIONS AND GRANTS ARE INCLUDED IN THE RESPECTIVE DEEDS.
