OWNERSHIP STATEMENT

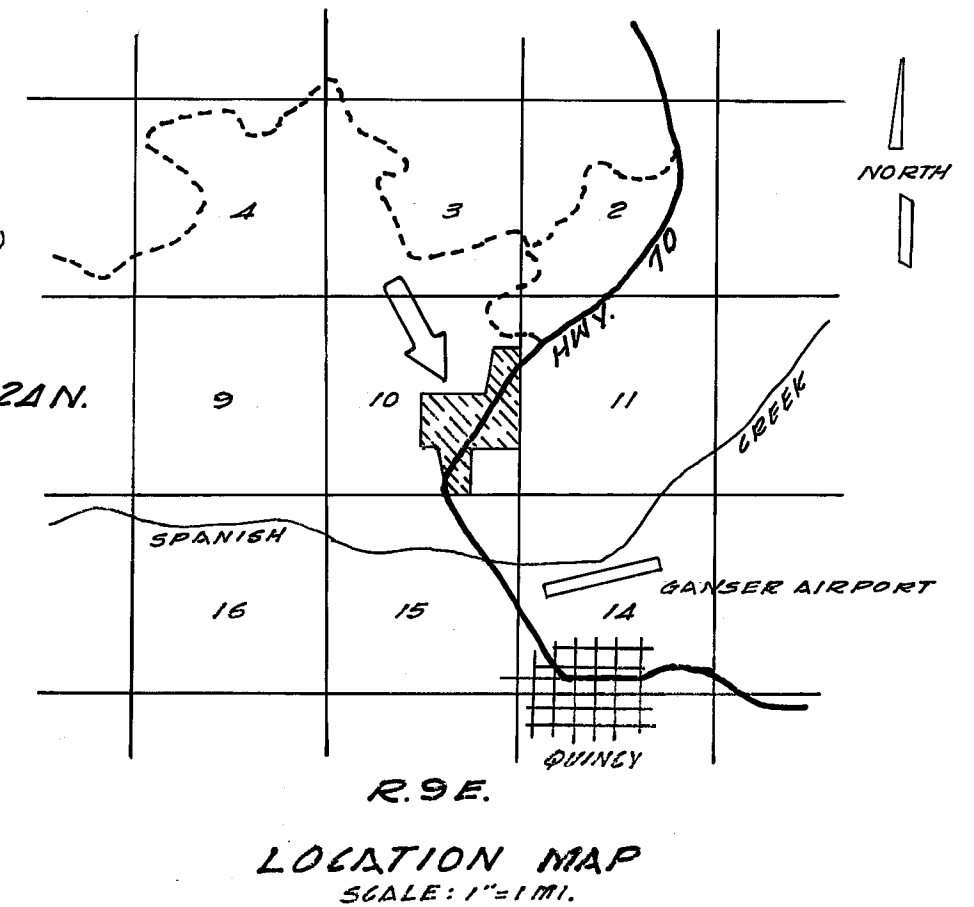

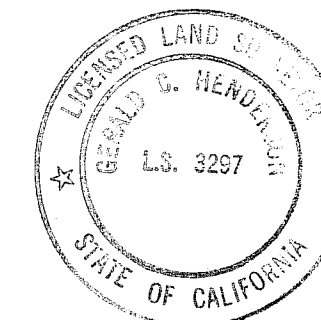
