


LOCATION MAP


OWNER'S STATEMENT




#### NOTES

Leach exclusion areas are all areas within 50' of property lines within easements, within 50' of water courses, within 100' of wells and for all slopes of 30% of greater.

Any perimeter fencing shall be restricted to smooth or barbed wire, no more than four strands, the lower to be a minimum of 16 inches above ground and the top strand to be no more than 48 inches above the ground.
