



## NOTES

1. Owner Consent: A certificate of ownership is on file with the County Recorder in Book 432 of Official Records of page 293. The certificate was signed by Robert L. Skillman and Neva Black Skillman and stated that they consent to the preparation and recording of this map, and that they are the only persons whose consent is required to pass title to said land.
2. Private Road Statement: Roads shown hereon; Ridge Circle Road is a private easement not subject to improvement or maintenance by Plumas County. Such easements will not become effective unless and until reservations and grants are included in the respective deeds.
3. Fire Protection: No authorized structural fire protection is currently provided to the lands shown hereon.
4. Designated Leachfield: Parcel 2 has a designated leachfield site for both parcels 1 & 2. No building will be permitted on this designated area. Any other site will require county concurrence.
5. This map is a division of Parcel 2 of 2 PM 60.
6. Easements A and B are to be granted to parcel 1 for water and leachfield purposes, and P.U.E.
