




General Notes:

Farris and Kathryn L. Farris and stated that they consent to the preparation and recording of this map, and that they are the only persons whose consent is required to pass title to said land.
- Leach exclusion areas include areas within 50' of lot lines, 50' from seasonal watercourses, 100' from wells, 100' from the irrigation ditch. The County Sanitarian may, at his sole discretion, approve the location of leach fields between

- the irrigation ditch and Chandler Road.
- Esm. "C" is a leachfield easement for the existing leachfield serving Parcel 2.
- This map is a division of Parcel 3 of 3PM65.
- Easement "D" is a leachfield easement to be granted to Parcels 1 and 2.
