BASIS OF BEARINGS

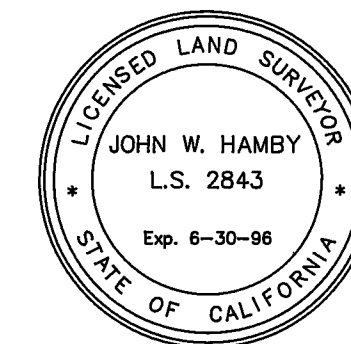
