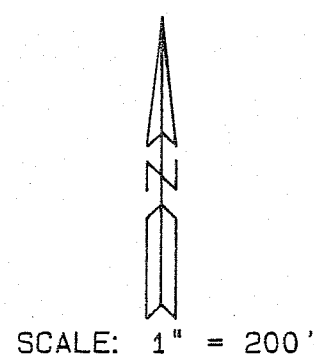


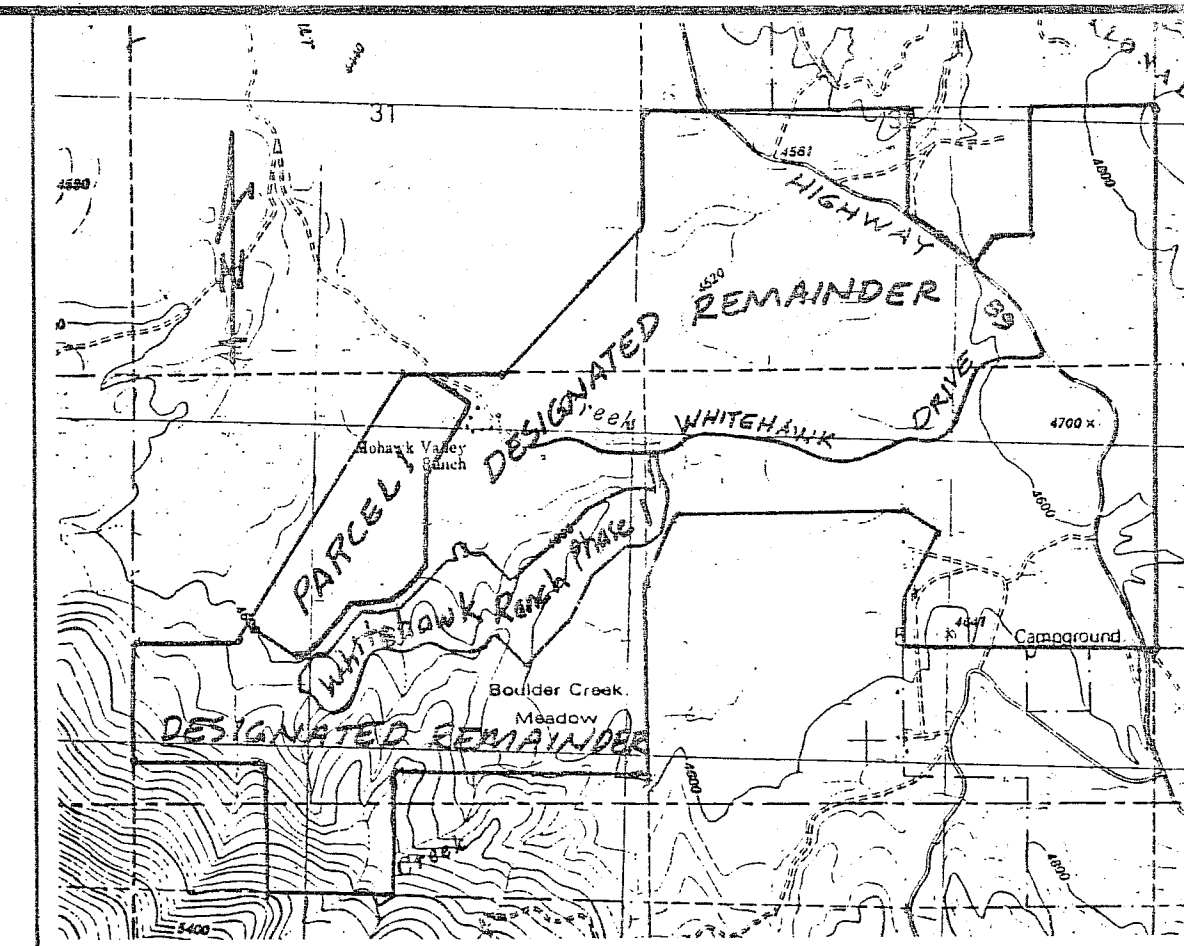
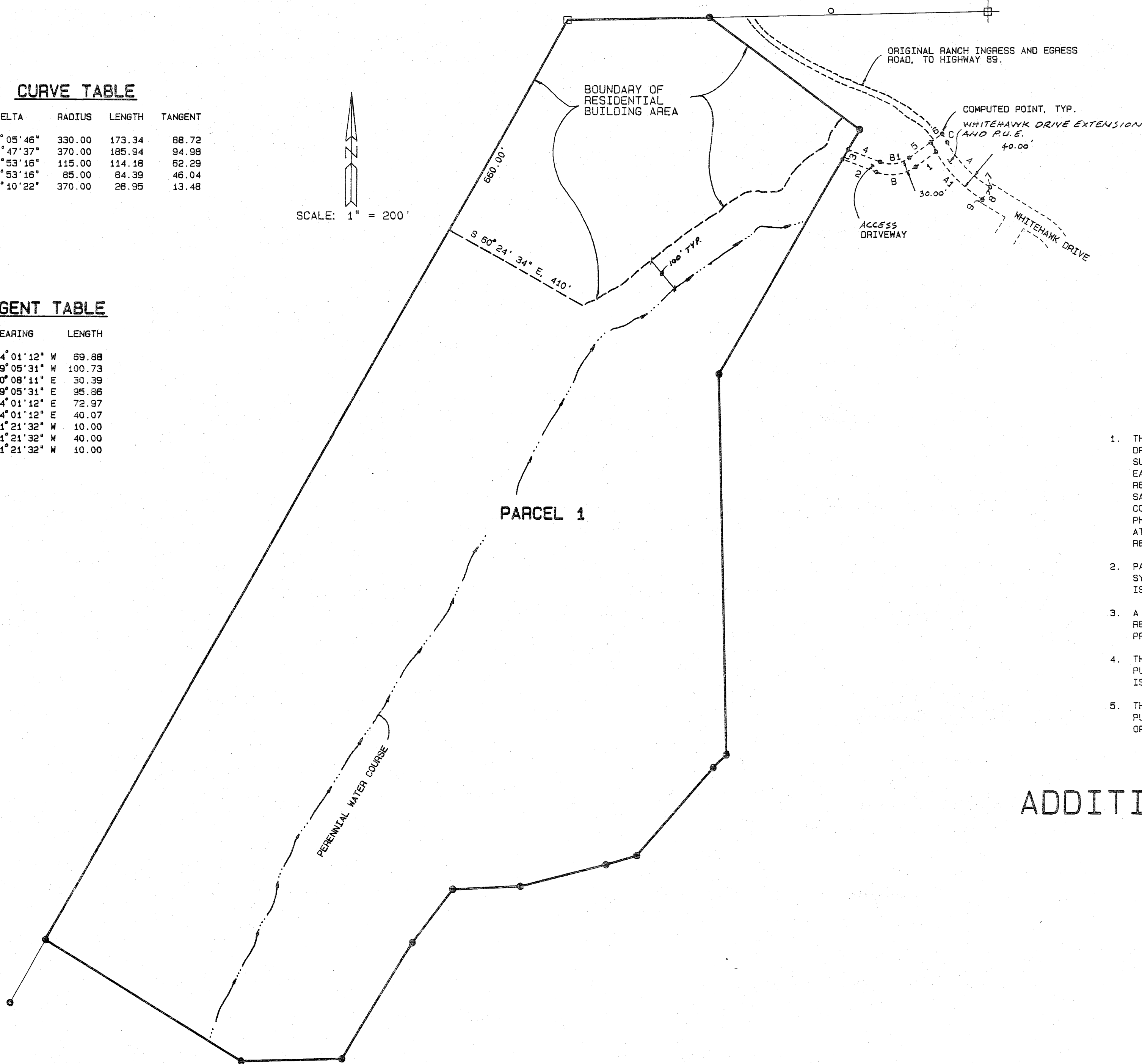

3. A 30' WIDE UTILITY EASEMENT FOR FUTURE UTILITIES WILL BE RESERVED IN THE DEED FOR PARCEL 1, TO PROVIDE FOR FUTURE PROJECT FACILITIES.
