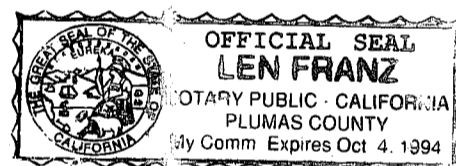

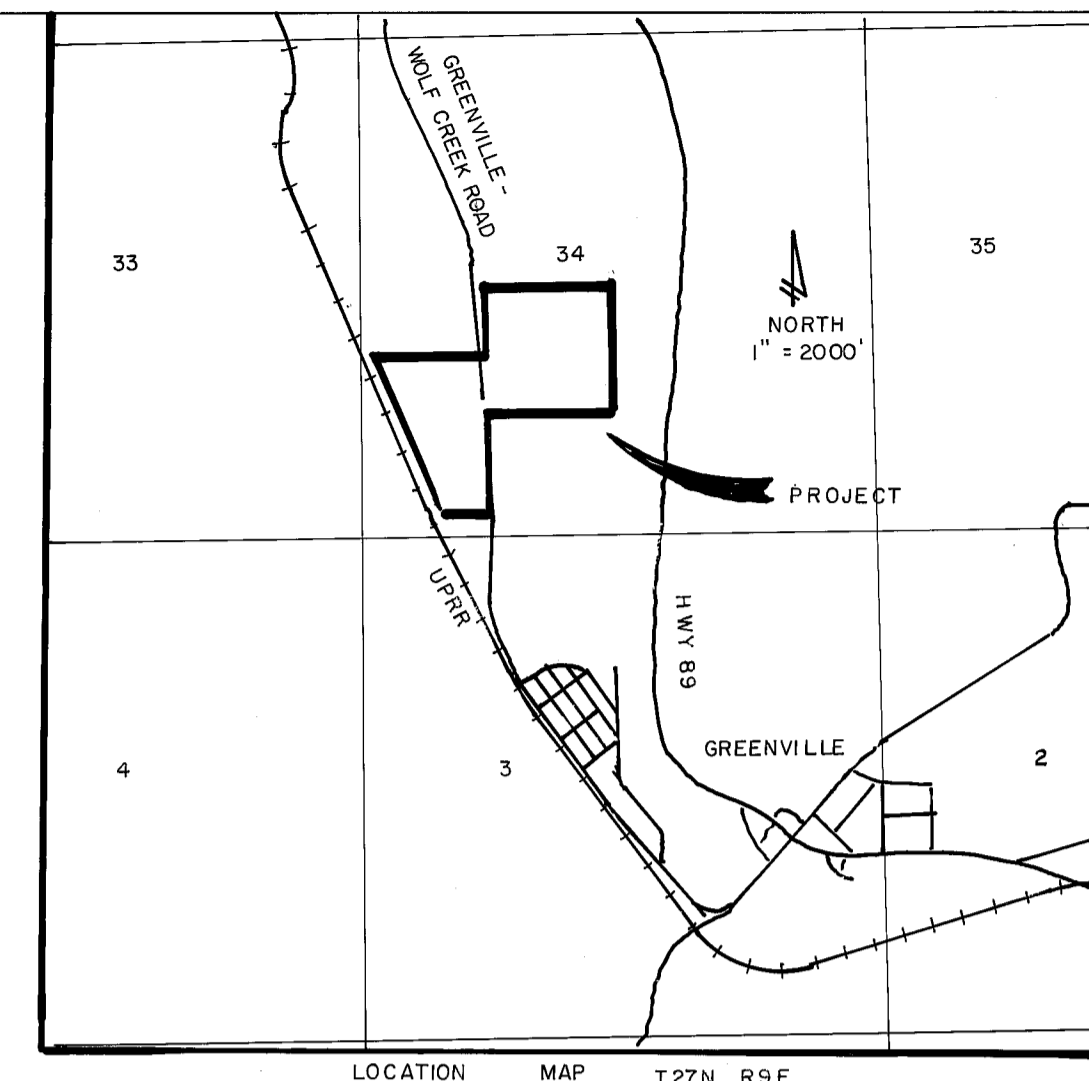

COUNTY TAX COLLECTOR'S CERTIFICATE

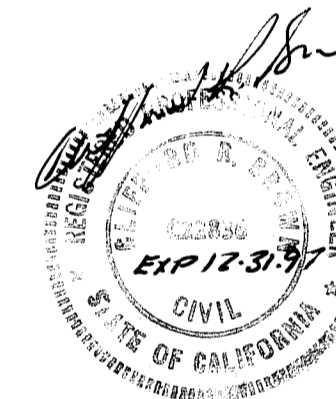
