


### BASIS OF BEARINGS

The Basis of Bearing for this survey is the line between the monument set at the east line of County Road 112 that lies N75°57'45"E, 30.00 feet from the northwest corner of Lot 3 of 6 M 63 and the southeast corner of said Lot 3, i.e. S39°45'28"E as calculated from 6 M 63.

### OWNER'S STATEMENT

A Certificate of Ownership is on file with the County Recorder as Document No. 2005-10411. The certificate was signed by Grace M. Limon, as Trustee, and states that she consented to the preparation and recording of this map, and that she is the only person whose consent is required to pass title to said land, and she offers for dedication a 20 foot wide easement for the purpose of gaining access to Parcel 2 for future monitoring by Plumas County and/or California State Agencies. Shown as Easement No. 1.




### COUNTY TAX COLLECTOR'S STATEMENT



### SURVEYOR'S STATEMENT



### NOTES

1. The sole purpose for preparation and filing of this Parcel Map is to specify the location of a former landfill site, shown hereon as Parcel 2, along with its relationship to the balance of Lot 3 of the Mill Race Subdivision, 6 M 64, said portion shown hereon as Parcel 1. Since the purpose of this map is to establish the boundary of the old landfill and an access easement to serve it together with building exclusion areas, only such property corners as were needed to show the landfill boundary and its relationship to the parent parcel were recovered and used in this survey.

2. This property may be encumbered by the following recorded instruments: Book 491 of Official Records at Page 579, a Road Maintenance Agreement and Book 433 of Official Records at Page 651, a road, drainage and utility easement to the County of Plumas.
