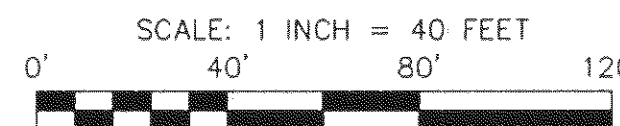
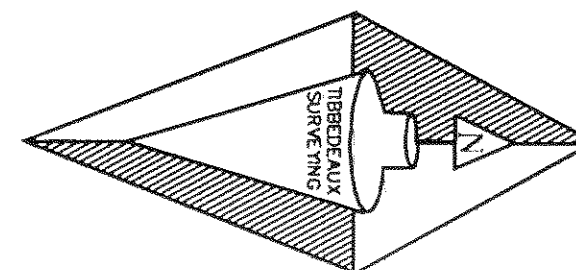

THE BEARING OF S 00°53'52" E FOR THE WEST LINE OF MAIN STREET SHOWN IN BOOK 14 OF RECORDS OF SURVEYS AT PAGES 67 AND 68 IS THE BASIS OF BEARING SHOWN ON THIS MAP. SAID BEARING IS BASED ON CALIFORNIA COORDINATE SYSTEM ZONE 1 (STATE PLANE 1927) AT THE CENTER OF SECTION SHOWN ON SAID MAP. ROTATE BEARINGS 00°40'57" COUNTERCLOCKWISE TO OBTAIN GEODETIC BEARING.

ENCUMBRANCE NOTE:

THE LAND SHOWN ON THIS MAP SHALL BE USED ONLY FOR SUCH PURPOSES AS DEFINED IN PLUMAS COUNTY, CALIFORNIA, ORDINANCE CODE AS RE-1-MO. 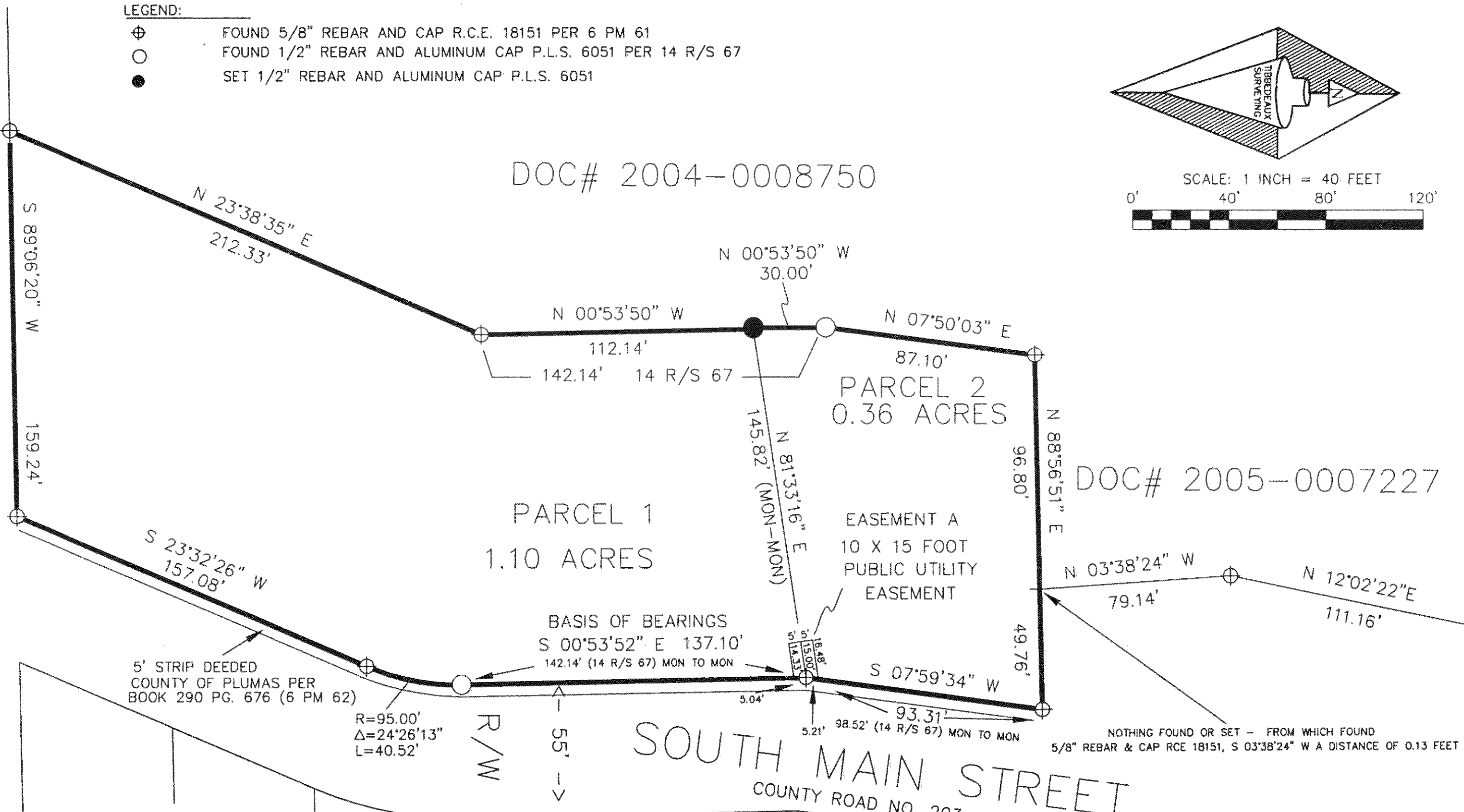

THE FOLLOWING EASEMENT OF RECORD, BOOK 41 OF DEEDS, PAGE 420, IS DEFINED IN SAID DEED AS A RIGHT OF WAY FOR DITCH, FLUME, PIPELINE OR OTHER WATER CONDUIT. THE LOCATION OF THIS RIGHT OF WAY IS NOT DEFINED OF RECORD AND NO PHYSICAL CONFLICT WITH THESE PARCELS WAS RECOVERED.
