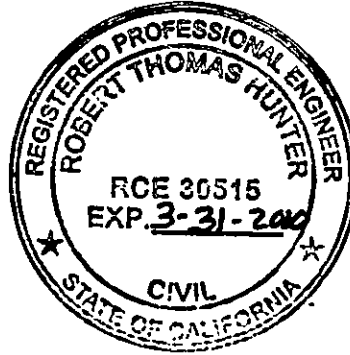


COUNTY TAX COLLECTOR'S STATEMENT

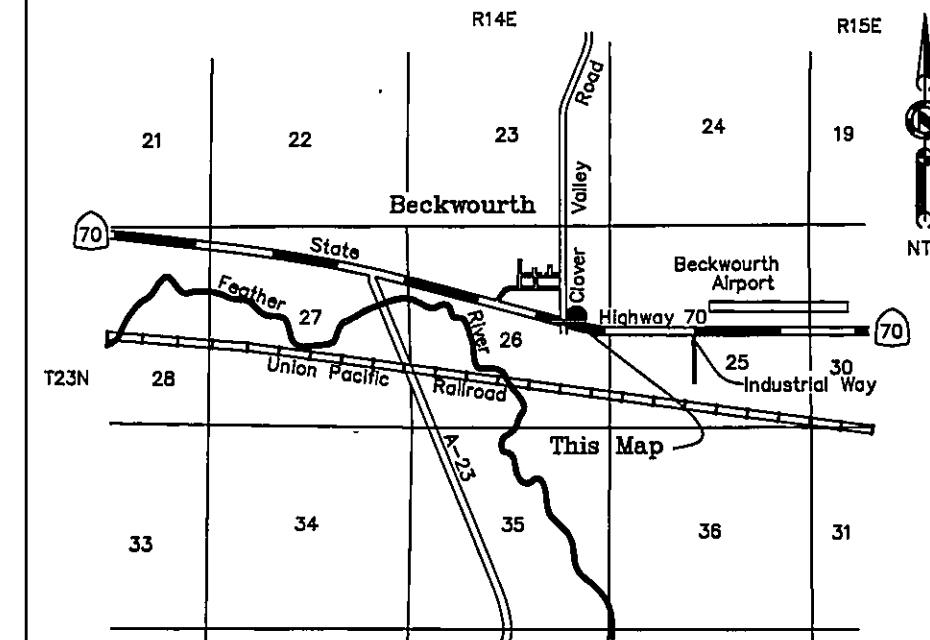


COUNTY SURVEYOR'S STATEMENT

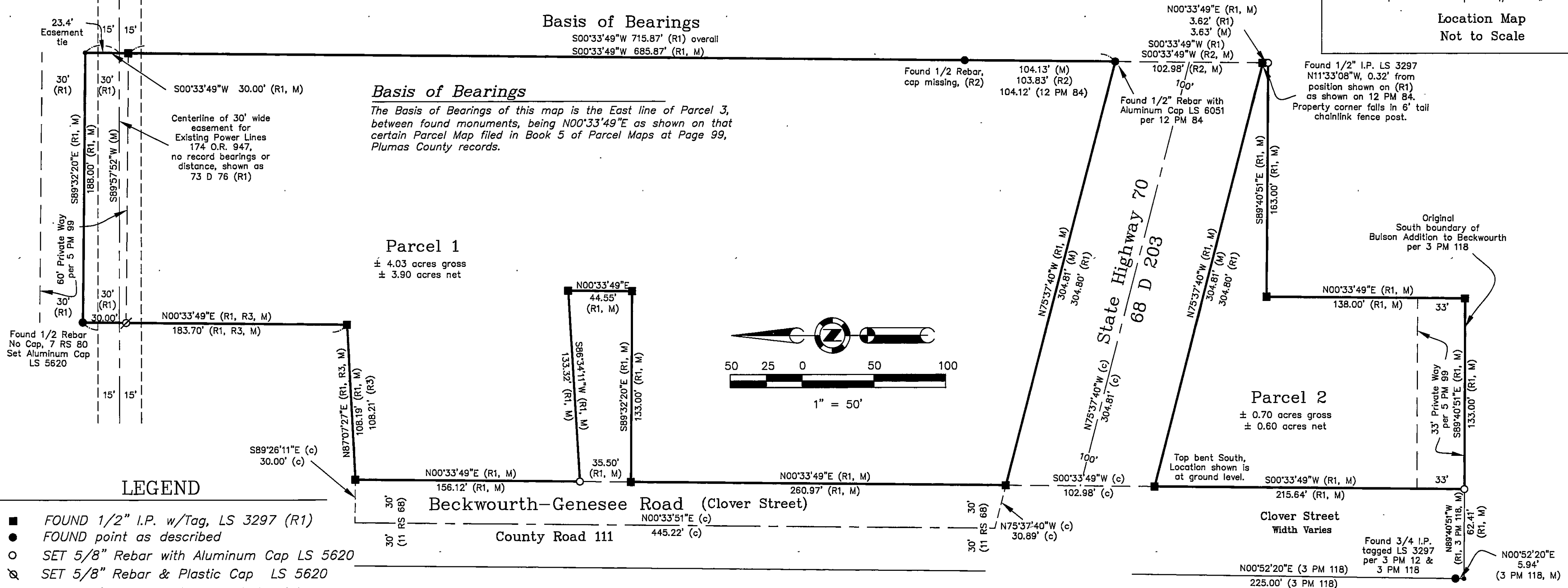
