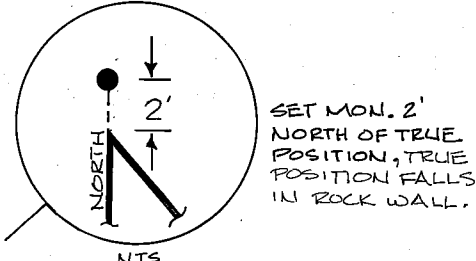
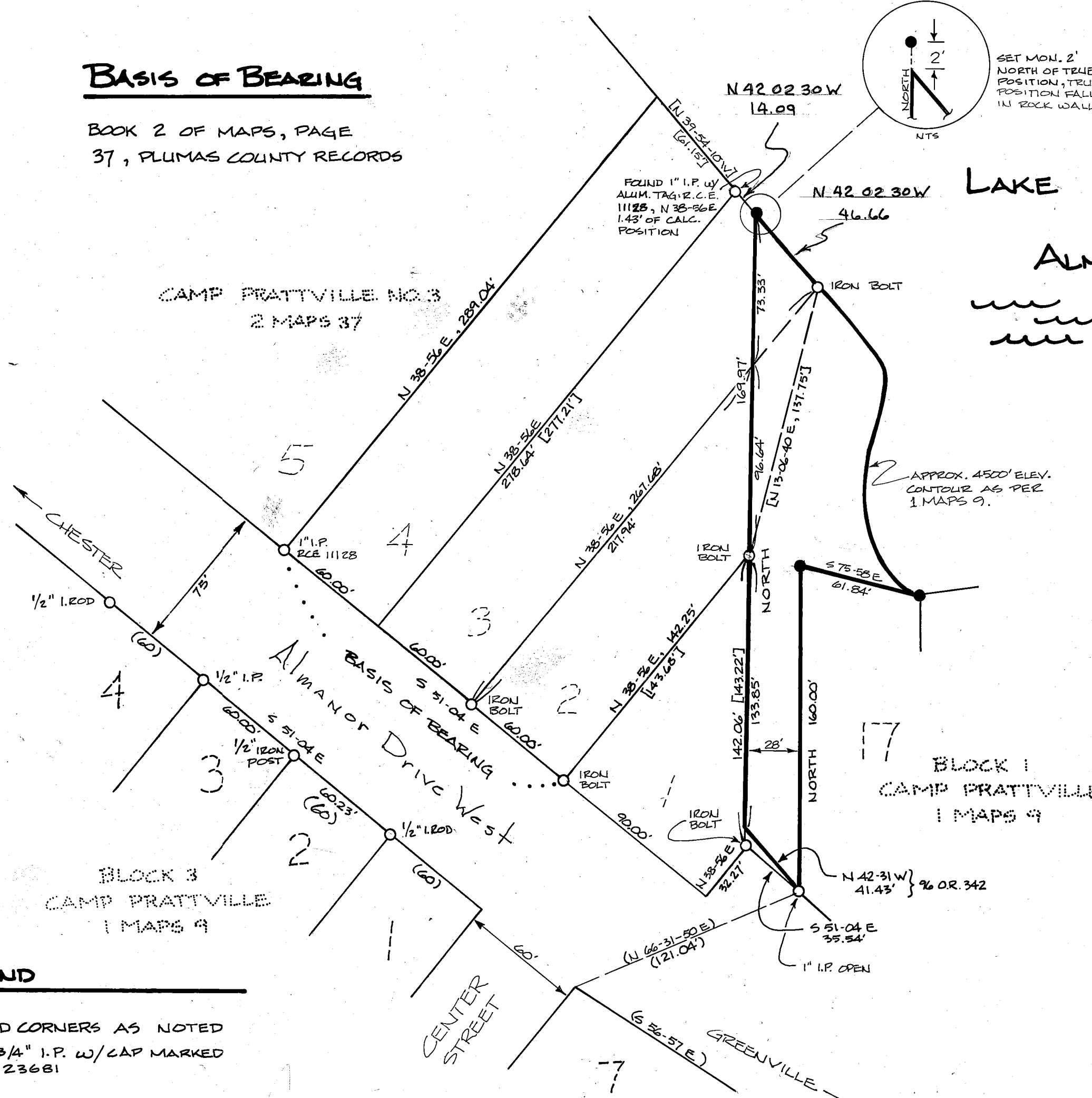


BASIS OF BEARING

BOOK 2 OF MAPS, PAGE 37, PLUMAS COUNTY RECORDS



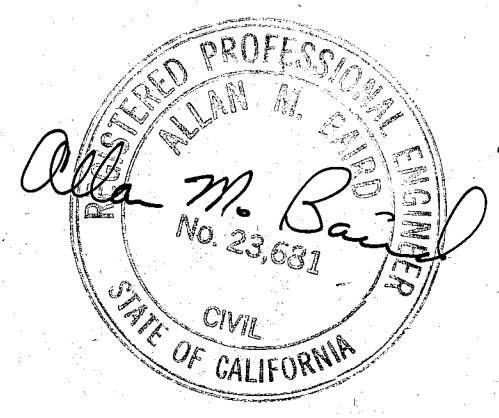
SURVEY NOTE:
THE PARCEL BOUNDED BY THE HEAVY LINE WAS CREATED BY THE DEED RECORDED AT 96 O.R. 342 ON JULY 11, 1956. WHEN OLIVER O. HOWARD, LS 2332, SUBSEQUENTLY PREPARED THE SUBDIVISION MAP OF CAMP PRATTVILLE NO. 3 (RECORDED AT 2 MAPS 37, ON JUNE 14, 1961), NO REFERENCE WAS MADE TO THIS DEED. AN AREA OF CONFLICT, SHOWN HERE BY DASHED LINES, WAS THEN CREATED BETWEEN 96 O.R. 342 AND LOTS 2 & 3 OF CAMP PRATTVILLE NO. 3.
