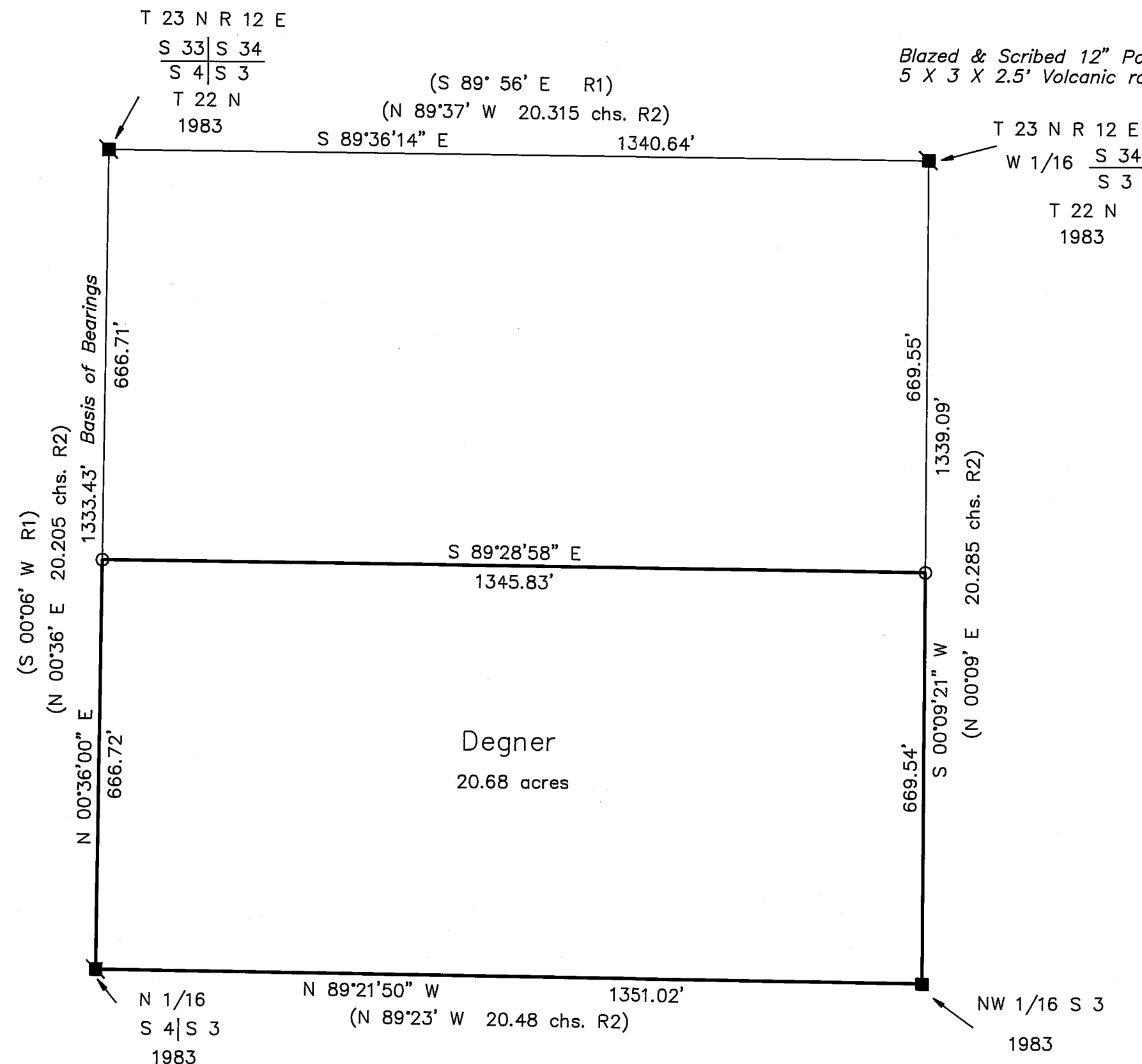


Basis of Bearing

The Basis of Bearings of this map is the West line of the NW 1/4 of Section 3, which is shown as N 00°36' E in B.L.M. field notes, see note.

Blazed & Scribed 10" Douglas fir bears N 56° E, 6.5 lks.
Blazed & Scribed 10" Black Oak bears S 39° 25' E, 45.5 lks.
Blazed & Scribed 9" Cedar bears S 64° W, 26 lks.
Blazed & Scribed 21" Cedar bears N 48° W, 33 lks.

Blazed & Scribed 12" Ponderosa pine bears N 54°30' W, 16 lks.
5 X 3 X 2.5' Volcanic rock bears S 42°50' W, 3 lks.



Dead Blazed & Scribed 11" Pine bears N 61°45' E, 16 lks.
Dead Blazed & Scribed 8" Ponderosa pine bears N 06°45' W, 66 lks.

2 1/2" Aluminum post & Cap stamped RM NW 1/16 S3 38 FT TO COR
bears S 30°49' W, 57.5 lks.
2 1/2" Aluminum post & Cap stamped RM NW 1/16 S3 43 FT TO COR
bears N 78°36' W, 65.0 lks.

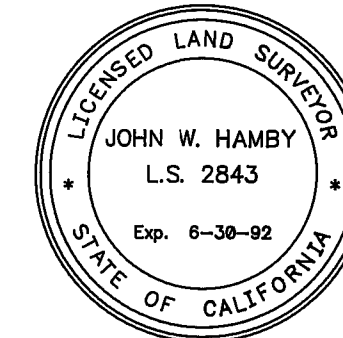
- FOUND B.L.M. 2 1/2" Aluminum post with Aluminum Cap, in mound of stone, stamped as shown.

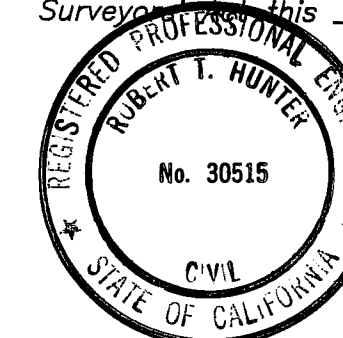
