




DETAIL N'LY CORNER

NOTE: No original monuments (A-45) were found. Monumentation from 3RS36 accepted as best evidence. After consideration of original map, and noting that the Cemetery lot and a large portion of Cemetery St. was undefined on original map, the following record distances and bearings (A-45) were held:

- 1) Portsmouth St from Nelson to Cemetery St.
- 2) Bearings along east side of Cemetery St. from monuments on south.
- 3) All adjustments made at Section Line
