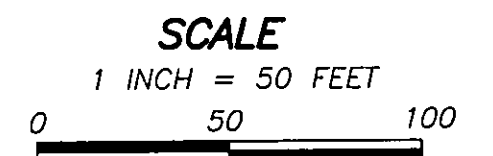


CORNER NOTES

NOTES

THE MONUMENTS FOUND AT THE CORNERS OF BLOCK A, AS MEASURED IN THE FIELD, WERE USED TO DETERMINE THE CALCULATED POSITIONS OF THE NORTHEAST AND NORTHWEST CORNERS OF LOT 2, BLOCK A. THESE CALCULATED POSITIONS WERE USED TO SET MONUMENTS AT 3, 6, 9, AND 10. THE CALCULATED POSITIONS OF THE NORTHEAST AND NORTHWEST CORNERS OF LOT 2, BLOCK A ARE GIVEN IN THE CORNER NOTES.

ALL INFORMATION IN PARENTHESES IS RECORD INFORMATION.
A STANDARD LS 7794 MONUMENT IS A 1/2" DIAMETER REBAR WITH A 1 1/2" DIAMETER ALUMINUM CAP STAMPED "RICHARD KNOETTGEN LS 7794".
