


NOTE:

THE CHARACTER AND POSITION OF THE EAST 1/4 CORNER OF SECTION 22, T24N R8E MDM, AS PER THE 1943 PARENT DEED OF 232 OR 95 IS UNKNOWN. THE ORIGINAL GLO 1/4 CORNER WAS RECOVERED ON 8/28/1981 AS PER 6 RS 14 AND IS REFERENCED IN THIS SURVEY. THE EXCEPTION (R3) REFERRED TO IN 232 OR 95 WAS NOT REFERENCED IN THIS SURVEY.






