OBSERVATIONS AND CORRECTIVE ACTIONS

Good sanitation at time of inspection. Found staff to be knowledgeable in food safety and cooperative to correct items during inspection as follows:

30. Found 3 kgs of grill chicken seasoning in deli walk-in refrigeration had cross contamination. Staff discarded during inspection.

35/36. Found hot holding deli tongs stored on edge of work table (folded up). Food debris on back of table could cross contaminate tongs. Find a better location for tong storage & clean regularly.
