

NOTICE OF ELECTION

NOTICE IS HEREBY GIVEN that an election will be held on November 7, 2023, within the boundaries of the Beckwourth Fire Protection District; Sierra Valley Fire Protection District; City of Portola; and the Gold Mountain Community Services District, to approve (1) formation of a new Fire Protection District herein "Beckwourth Peak Fire Protection District"; (2) a special tax measure for the proposed new "Beckwourth Peak Fire Protection District"; and (3) electing five (5) new board members, by a two-thirds majority vote, of the following measures:

MEASURE E:

"To build and sustain adequate community fire and rescue services for the eastern region of Plumas County, shall the order adopted on June 26, 2023 by the Plumas Local Agency Formation Commission ordering the reorganization affecting the Beckwourth Fire Protection District, Sierra Valley Fire Protection District, Gold Mountain Community Services District, and City of Portola and providing for the formation of the "Beckwourth Peak Fire Protection District" in the territory described, subject to terms and conditions specified in the order, including a special tax to finance district services, be confirmed?"

MEASURE F:

"To build and sustain adequate community fire and rescue services for the eastern region of Plumas County, including adequate funding for staffing coverage, insurance, fuel, and essential equipment, shall a measure imposing an annual special tax for each parcel dependent on use; with a base rate of \$110 for improved single family residential parcels under 1,800 square feet, and parcels with other uses will be charged at various rates based on usage, raising an estimated \$405,000 annually until repealed by voters, be adopted in accordance with the terms and conditions of the Beckwourth Peak Fire Protection District Formation?"

NOTICE IS FURTHER GIVEN that the dates for filing arguments for or against the measure is July 12, 2023 through July 21, 2023 at 5:00 p.m. Arguments may not exceed 300 words each and must be accompanied by a "Form Statement" available at www.plumascounty.us, signed by each author. Rebuttals to arguments in favor or against the measure may not exceed 250 words and must be filed with the County Clerk by August 2, 2023 at 5:00 p.m.

NOTICE IS FURTHER GIVEN, that Declaration of Candidacy forms for eligible candidates may be obtained from the Plumas County Election Department at 520 Main Street Room 102, Quincy, and must be filed in the Election Department beginning July 17, 2023 through August 11, 2023 at 5:00 p.m. Deadline to withdraw as a candidate is August 11, 2023 by 5:00 p.m. Candidates may withdraw a Statement of Qualifications before August 14, 2023 by 5:00 p.m.

The office of the Plumas County Clerk Elections Division located in the Courthouse at 520 Main Street, Room 102, Quincy will be the processing place for all ballots from October 10, 2023 through November 7, 2023. Equipment testing will be September 26, 2023 at 9:00 am and is open to the public. For more information, call (530) 283-6256.
