# SHARE VISION FOR REBUILDING –

## COUNTY AND COMMUNITY IMPACTS AND NEEDS

- 768,130 acres burned in Plumas County (46% of total acreage) (source: CAL FIRE, Fire Perimeters, 2022)
- 68% of Lassen Volcanic National Park burned, including complete loss of Mount Harkness Fire Lookout (source: National Park Service, August 2022)
- Over 600,000 acres assessed as moderate-to-high soil burn severity (source: USDA Forest Service, Burned Area Reports, 2021)
- 745 erosion control measures, and 451 asbestos abatements conducted (source: CalRecycle, State of California's Consolidated Debris Removal and Hazard Tree Removal Program, 2022)
- 21,957 trees felled under Hazard Tree Removal Program (source: CalRecycle, State of California's Consolidated Debris Removal and Hazard Tree Removal Program, 2022)
- 779 damaged or destroyed residences (source: CAL FIRE, Damage Inspection Specialist (DINS), 2022)
