**MINUTES FOR THE REGULAR MEETING ON MONDAY, OCTOBER 28, 2024,  
BEGINNING AT 10:00 A.M. IN THE CONFERENCE ROOM OF THE PUBLIC WORKS  
BUILDING, 1834 EAST MAIN STREET, QUINCY, CA 95971**

1. Ms. Graham called the meeting to order at 10:00 am and took roll call. Present: Faith Strailey, Marsha Roby, Jeff Engel, Miki Brown and John Forno.
2. The following members of the public were present: Richard Ross from InterMountain disposal and Christian Garcia from Feather River Disposal. The following Public Works Staff were present: Sean Graham, Solid Waste Program Manager.
3. Graham opened the meeting for public comment: Mr. Garcia introduced a news letter regarding recycling education that was produced by FRD. Garcia explains that this will be mailed to FRD customers. Strailey expressed hope that this will reduce contamination and recommends that this information be published at Transfer Stations as well.

Ross explains that the fire hydrant at the Delleker transfer station is broken and that the community services district has been unresponsive. Engel said that he would contact the community services district to resolve the issue. Finally Graham and Ross inform the task force members that in the near future the Graeagle transfer station will be reorganized to be more streamlined.

4. Graham opened the meeting to discussion of SB 1383 and related developments. Graham explained that AB2902 was recently passed by the California State Legislature and that

this extends the County's SB 1383 rural exemption by 10 years with the possibility for 5-year extension following that period.

5. Graham opened the meeting to discussion of Franchise Contractor's received comments and complaints. Graham said that she reviewed the log provided by FRD and that some of the comments listed as positive seemed more neutral in sentiment. Garcia explained that the logs are graded by A.I. and that sometimes comments that display mixed sentiment can be labeled as positive. He went on to express that there is room for human review of the grading moving forward.

Roby expressed that many of the negative comments are regarding rates being high. She went on to express that she believes that better education regarding the rate adjustment process might ease customers' frustrations.

6. Graham explained that the next meeting would be Monday, January 29<sup>th</sup>, 2024. Brown motioned to adjourn, Strailey seconded the motion and all present members voted in favor of adjourning.
